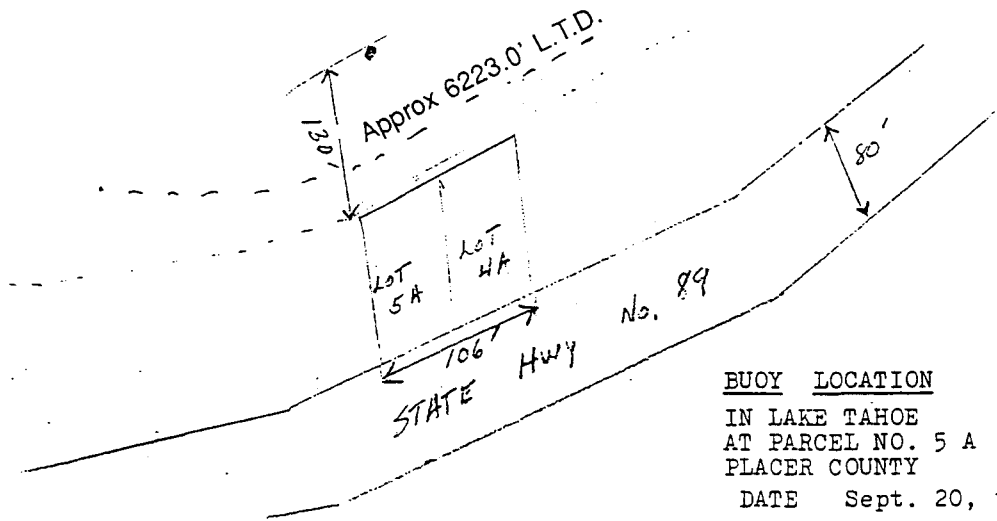
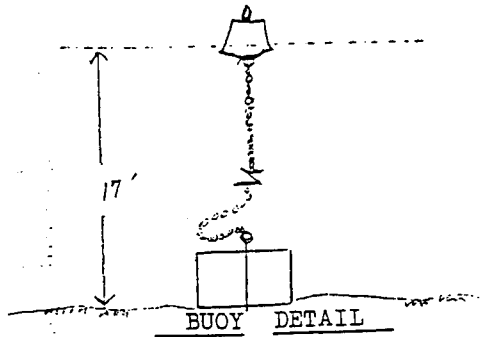

BUOY LOCATION

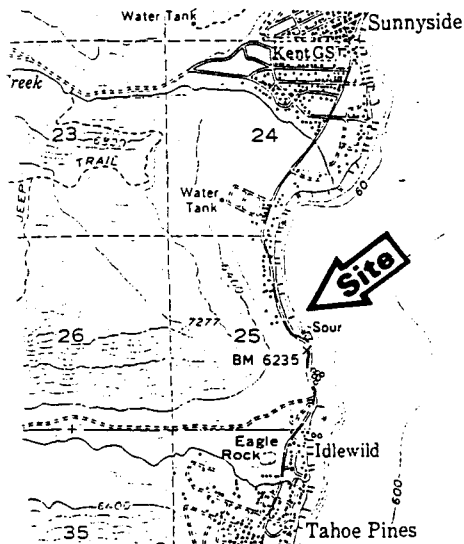

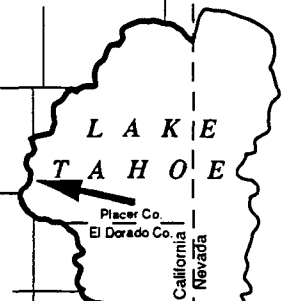
LOCATION MAP
