ASSIGNMENT AND RENEWAL OF LEASE TERMS OF A GENERAL LEASE - RIGHT-OF-WAY USE

ASSIGNOR:

Chevron U.S.A., Inc., a Corporation Post Office Box 1392 Bakersfield, California 93302

ASSIGNEE/LESSEE:

Union Oil Company of California (UNOCAL) 2141 Rosecrans Avenue, #400 El Segundo, California 90245

AREA, TYPE LAND AND LOCATION:

A 2.671-acre parcel, more or less, of tide and submerged land located in San Pedro Bay at the mouth of the San Gabriel River, Orange County.

LAND USE:

Continued use and maintenance of existing submarine pipe lines and a power cable which serve Platform Esther, Lease No. PRC 3095.1, in the Pacific Ocean.

LEASE:

The existing lease was issued for an initial period of fifteen years beginning October 21, 1965. The lease terms provide for the right to renew for three additional periods of ten years each.

CONSIDERATION:

\$1,950.00 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

- 1. This is an assignment and renewal of Lease No. PRC 3394.1 and includes the following existing facilities.
 - 1 12" crude pipeline (abandoned in place)
 - 1 10" crude pipeline
 - 1 10" gas line
 - 1 4" water line
 - 1 6" armored KVA cable
- 2. In 1990, staff received information from UNOCAL that they acquired Lease No. PRC 3394.1, along with several other State leases from Chevron in December 1988. At that time, staff provided assignment documents to both parties. The assignment documents were never executed or returned for Commission review and approval. Concurrently, the lease expired on October 21, 1990, and the option to extend was not exercised. The lease has been in a month to month tenancy since October 1990 with UNOCAL paying the annual rent for the lease.
- 3. Staff recently received information that UNOCAL desires to assign their interest in PRC 3394.1 to Nuevo Energy Company.
- 4. The Commission is being requested to further assign Lease No. PRC 3394.1 to Nuevo Energy Company by a separate Calendar Item.
