AUTHORIZE ISSUANCE TO E. L. YEAGER CONSTRUCTION COMPANY, INC. OF A ONE YEAR AND SEVEN MONTH GENERAL LEASE - TEMPORARY RIGHT OF ENTRY USE, SUBSTANTIALLY IN THE FORM ON FILE IN THE OFFICES OF THE COMMISSION, BEGINNING MAY 1, 1996; IN CONSIDERATION OF PAYMENT IN THE AMOUNT OF \$.02 PER CUBIC YARD OF ENGINEERED FILL MATERIAL PLACED ON THE PREMISES; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$1,000,000 AND SURETY BOND IN THE AMOUNT OF \$5,000.

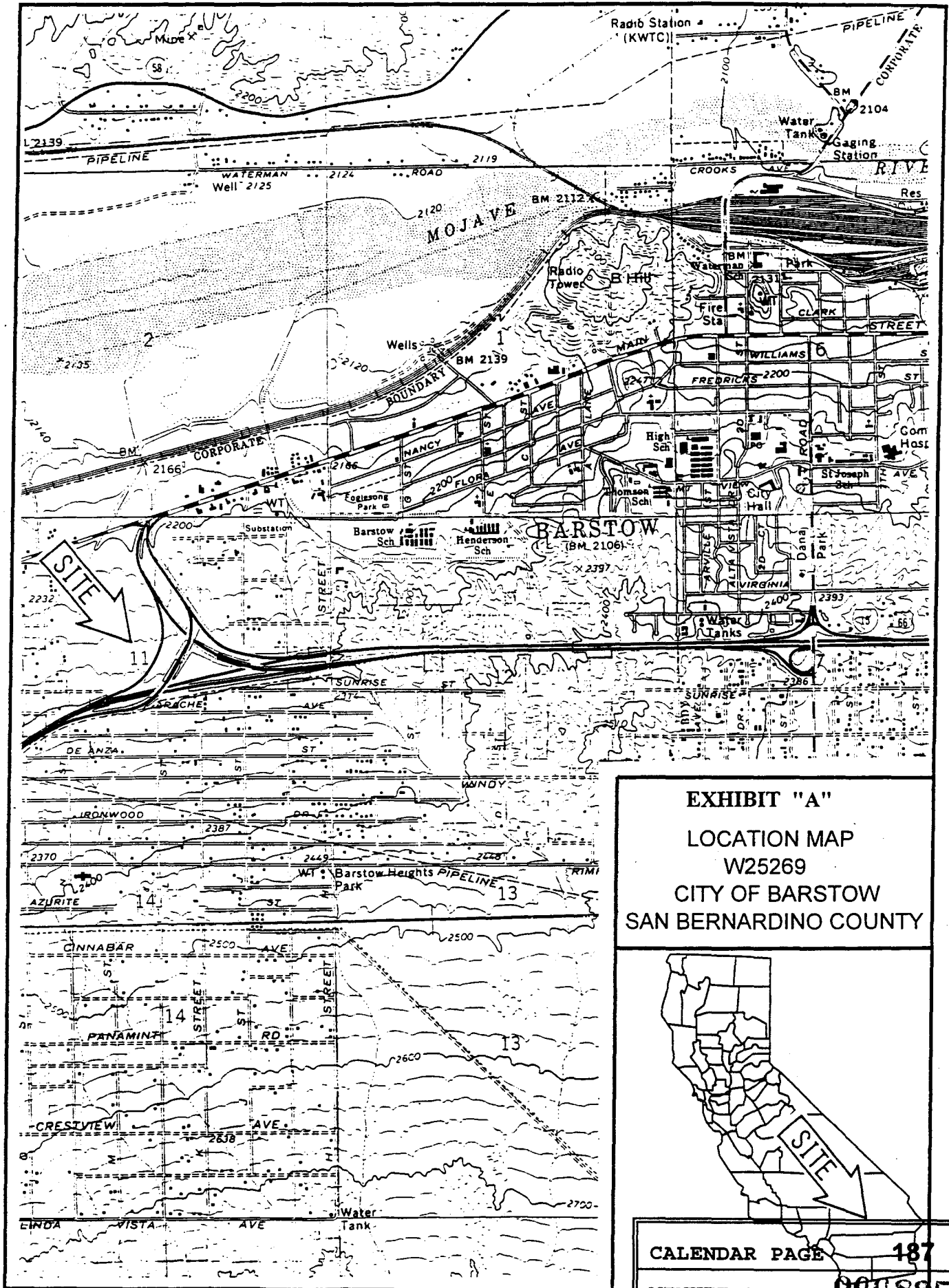


EXHIBIT "A"
