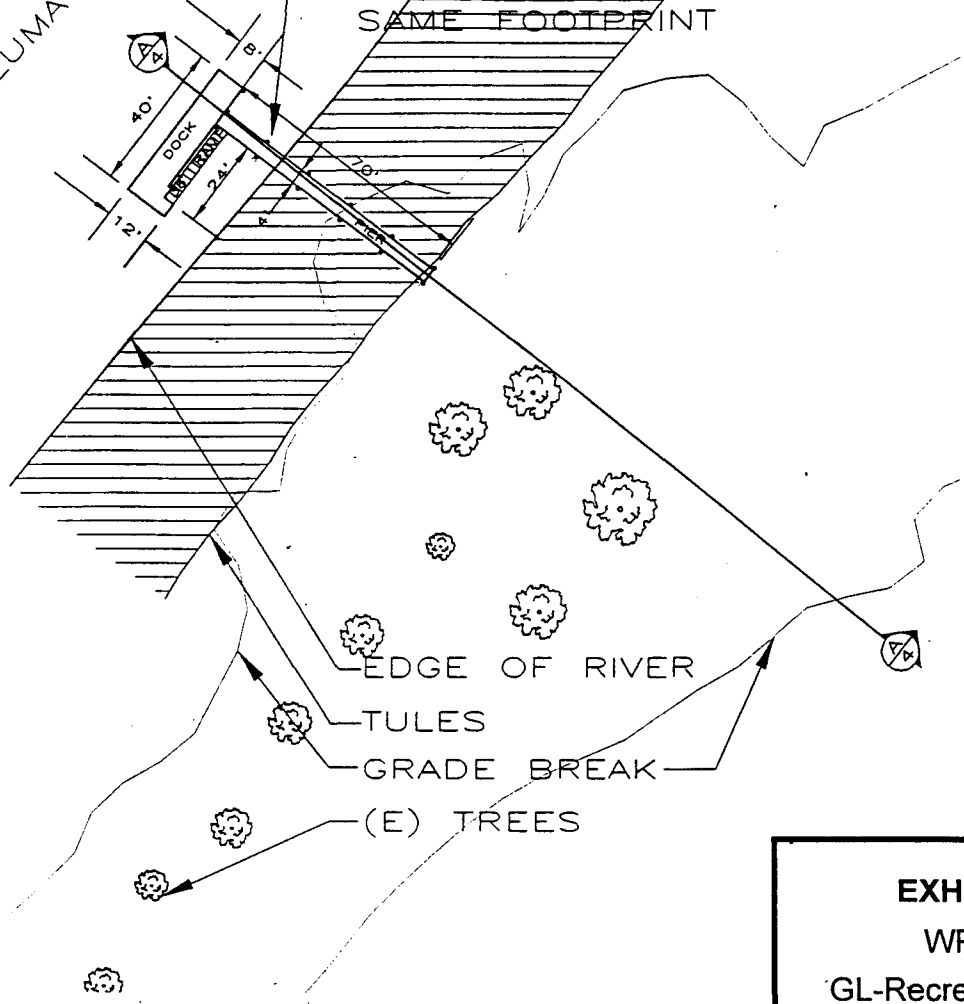


EXHIBIT "A"

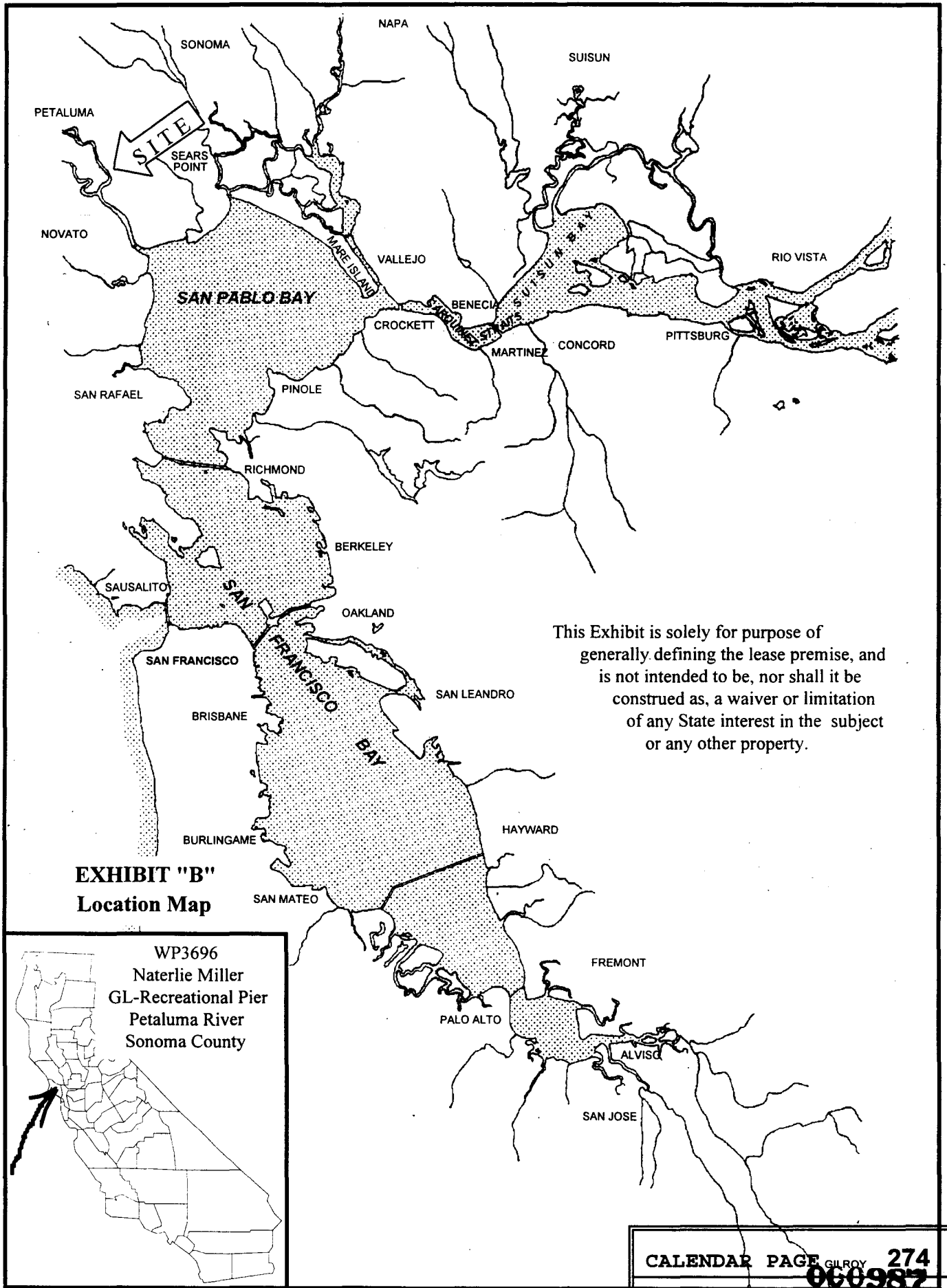


EXHIBIT "B"
