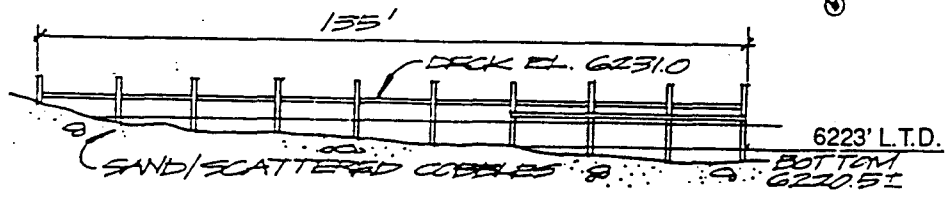

LOCATION MAP

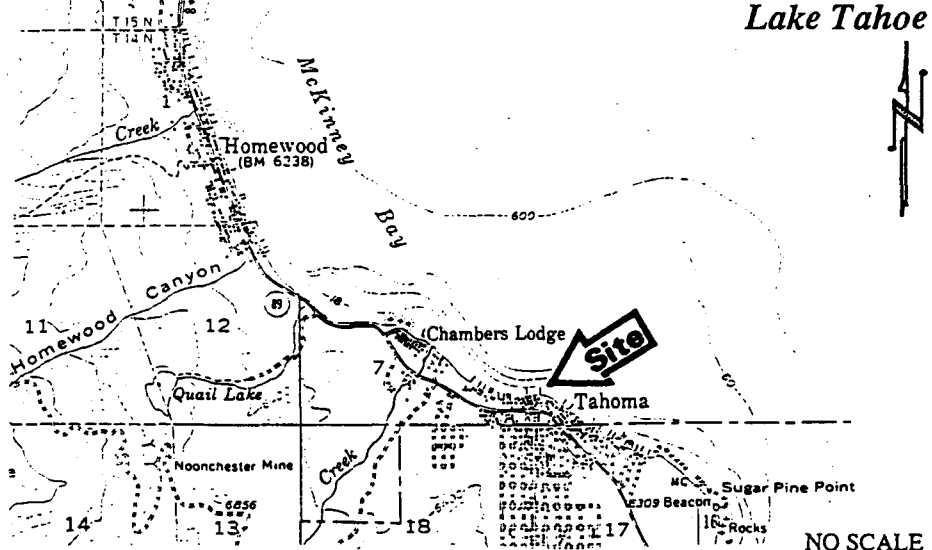
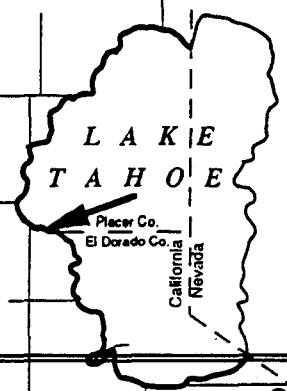
