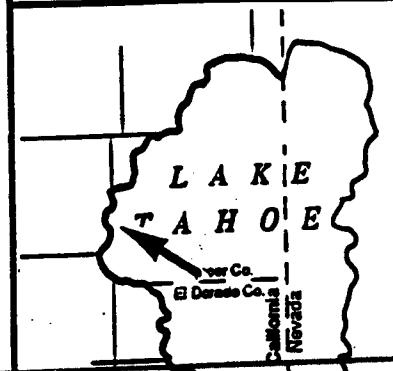
LOCATION MAP

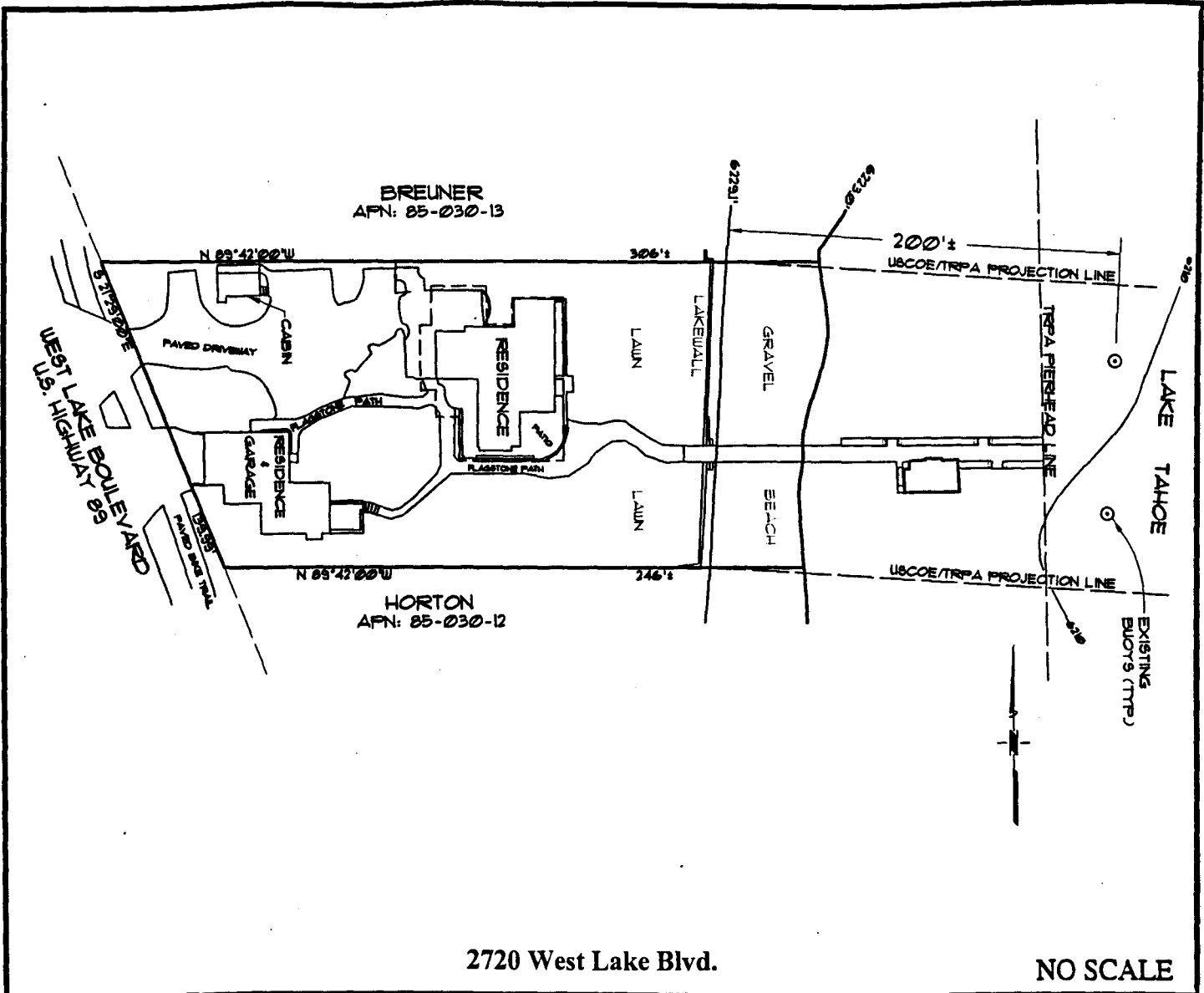

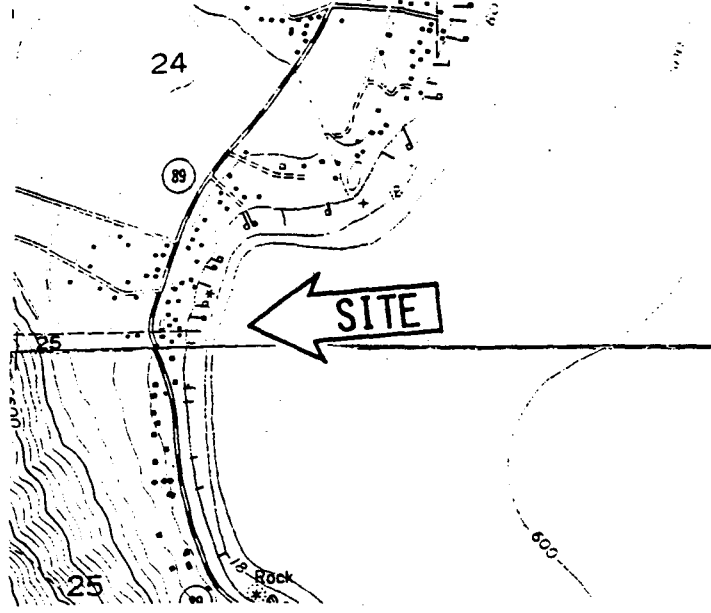

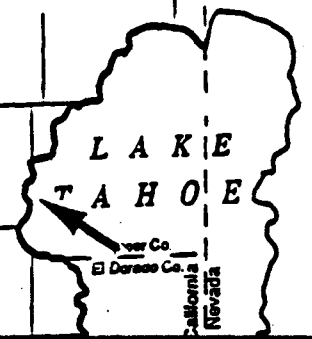
