ASSIGNMENT AND CONSENT TO ENCUMBER GENERAL LEASE - COMMERCIAL USE

LESSEE/ASSIGNOR:

The Heirs and Devisees of Lyman B. Sutter, Jr., dba Richardson's Marina and/or Camp Richardson Resort and Marina, Inc. aka Anchorage Marina

PROPOSED ASSIGNEE:

Seven Summits Corporation dba Camp Richardson Resort, Inc.

LOCATION:

A 3.4 acre parcel, more or less, of submerged land located in the bed of Lake Tahoe at Camp Richardson, El Dorado County.

AUTHORIZED USES:

Operation of a commercial marina.

TERM:

Twenty years beginning July 22, 1982, and ending July 21, 2002.

CONSIDERATION:

- 1. A minimum annual rental of \$825 applied against five percent of gross income derived from the rental of moorings; one cent per gallon of fuel sold during the reporting period to a maximum of 100,000 gallons and one and one half cents per gallon thereafter, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.
- During review of this lease, it was determined that there were unauthorized activities conducted on the Lease Lands and that rental payments were in arrears. Staff propose a negotiated settlement to resolve all use and back rent issues with regard to this lease. As part of this comprehensive settlement, Staff recommends waiver of penalty and interest on back rent

OTHER PERTINENT INFORMATION:

This lease was originally issued on February 4, 1985 to Richard Schwartz, dba Richardson's Marina and/or Camp Richardson Resort and Marina, Inc. The Commission later approved an assignment of the lease by Schwartz to Lyman Sutter, effective September 23, 1985. Upon the death of Mr. Sutter, the lease was transferred to his Heirs and Devisees, effective August 15, 1988. The Heirs and Devisees now request approval of the assignment of the lease to Seven Summits Corporation, dba Camp Richardson Resort, Inc. The Heirs and Devisees are selling the business to Seven Summits and will remain as a secured party lender under a note from Seven Summits. They are also seeking Commission approval of the encumbrance of the lease premises as partial security for this note.
