Operation of existing utility lines: 4-inch diameter water pipeline, electric power line, and a telephone line.

**CURRENT LEASE TERMS:**

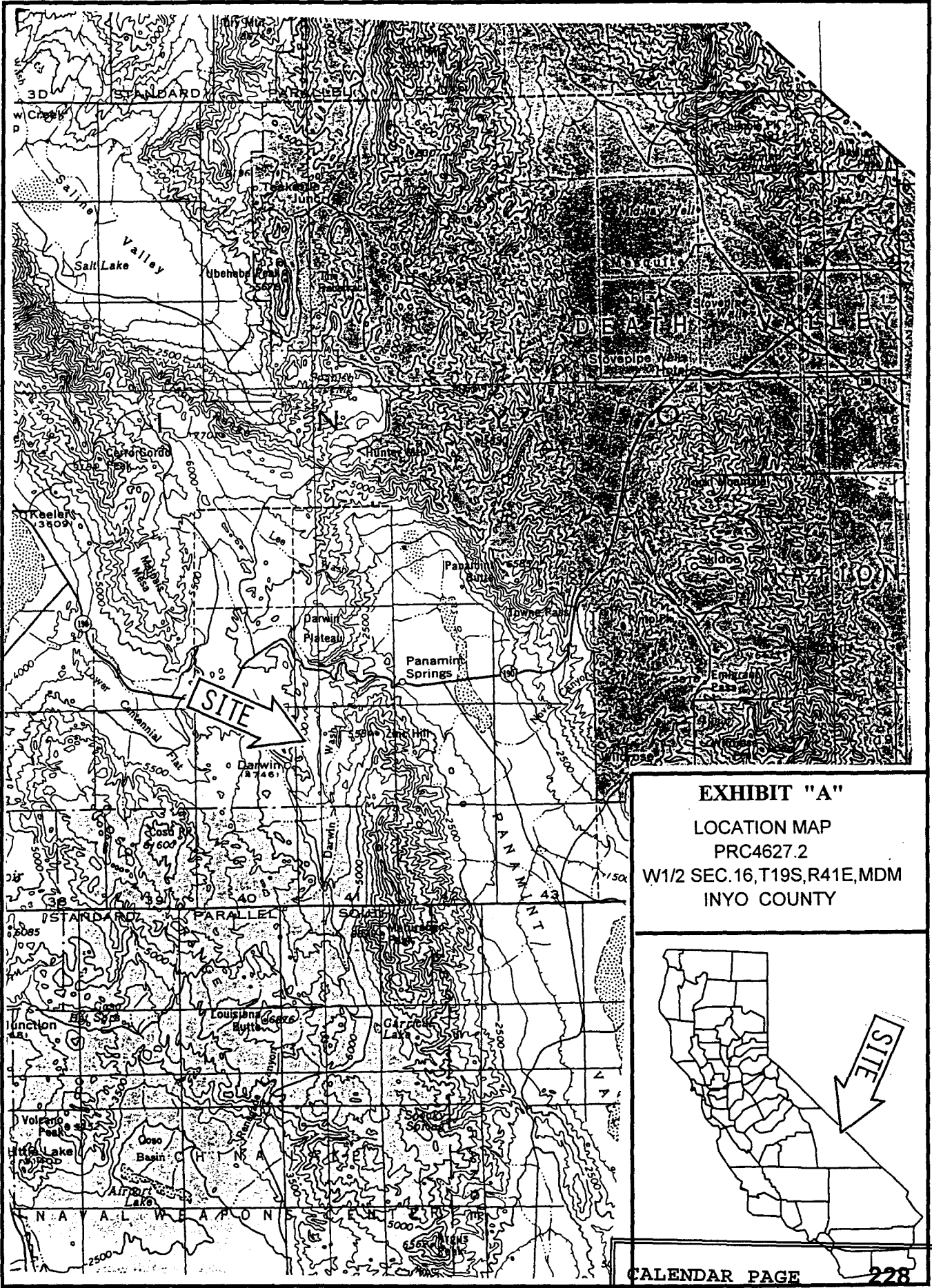
