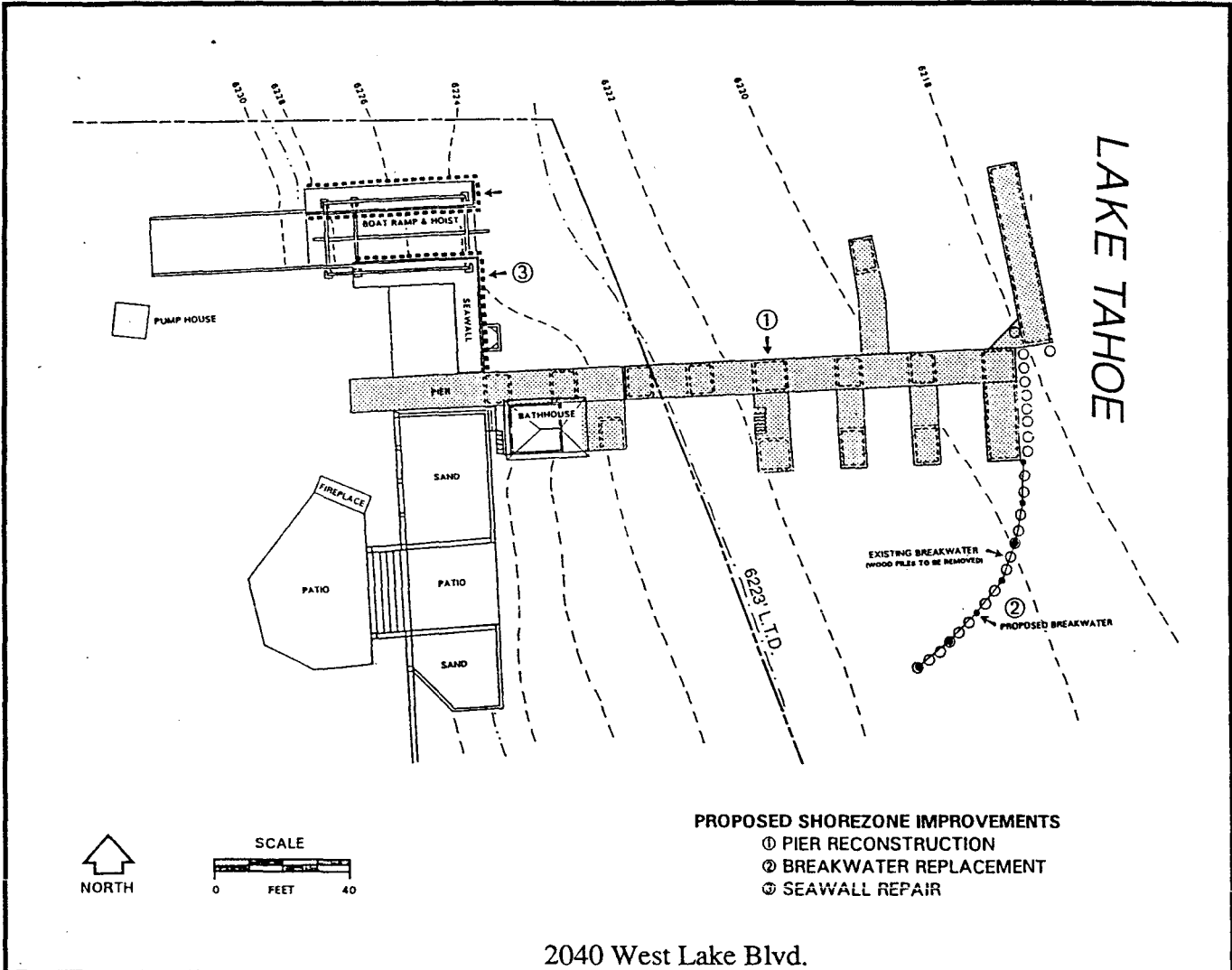

LOCATION MAP

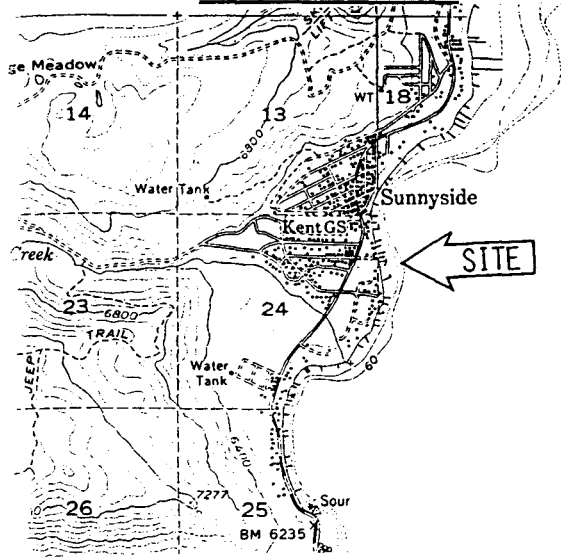
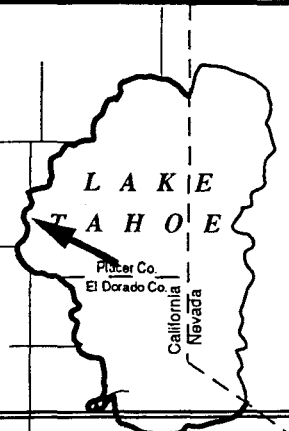
