FIRST AMENDMENT TO GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

Truckee Donner Recreation and Park District
P.O. Box 1087
Truckee, California 96160

LOCATION:

Submerged land in Donner Lake near Truckee, Nevada County.

AUTHORIZED USE:

Continued use and maintenance of eleven (11) existing piers and the construction of a new pier with access for the physically disabled, for a total of twelve (12) piers.

TERM:

Forty-nine years beginning August 1, 1974.

CONSIDERATION:

Public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

CALENDAR ITEM NO. C65 (CONT'D)

OTHER PERTINENT INFORMATION:

On August 1, 1974, the Commission issued a 49-year Public Agency Lease (Calendar Item C26) to the Truckee Donner Recreation and Park District (District) for the maintenance and repair of ten (10) piers for recreational purposes. However, in actuality, there are eleven (11) piers (one of the piers was omitted).

The District wishes to construct a new pier with access for the physically disabled. This Amendment is to authorize the construction of the new pier and to include the previously omitted pier, in the lease, for a total of twelve (12) piers.

RECOMMENDED ACTION:

IT IS RECOMMENDED THAT THE COMMISSION:

CEQA FINDING: (EXISTING RECREATIONAL FACILITIES)

FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A STATUTORILY EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 2 CAL. CODE REGS. 2905 (a) (2).

CEQA FINDING: (DISABLED FISHING ACCESS PROJECT)

FIND THAT A NEGATIVE DECLARATION (SCH 93122035) WAS PREPARED AND ADOPTED FOR THIS PROJECT BY THE TRUCKEE-DONNER RECREATION AND PARK DISTRICT AND THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED THEREIN.

SIGNIFICANT LANDS INVENTORY:

FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO PUBLIC RESOURCES CODE SECTIONS 6370, ET SEQ.

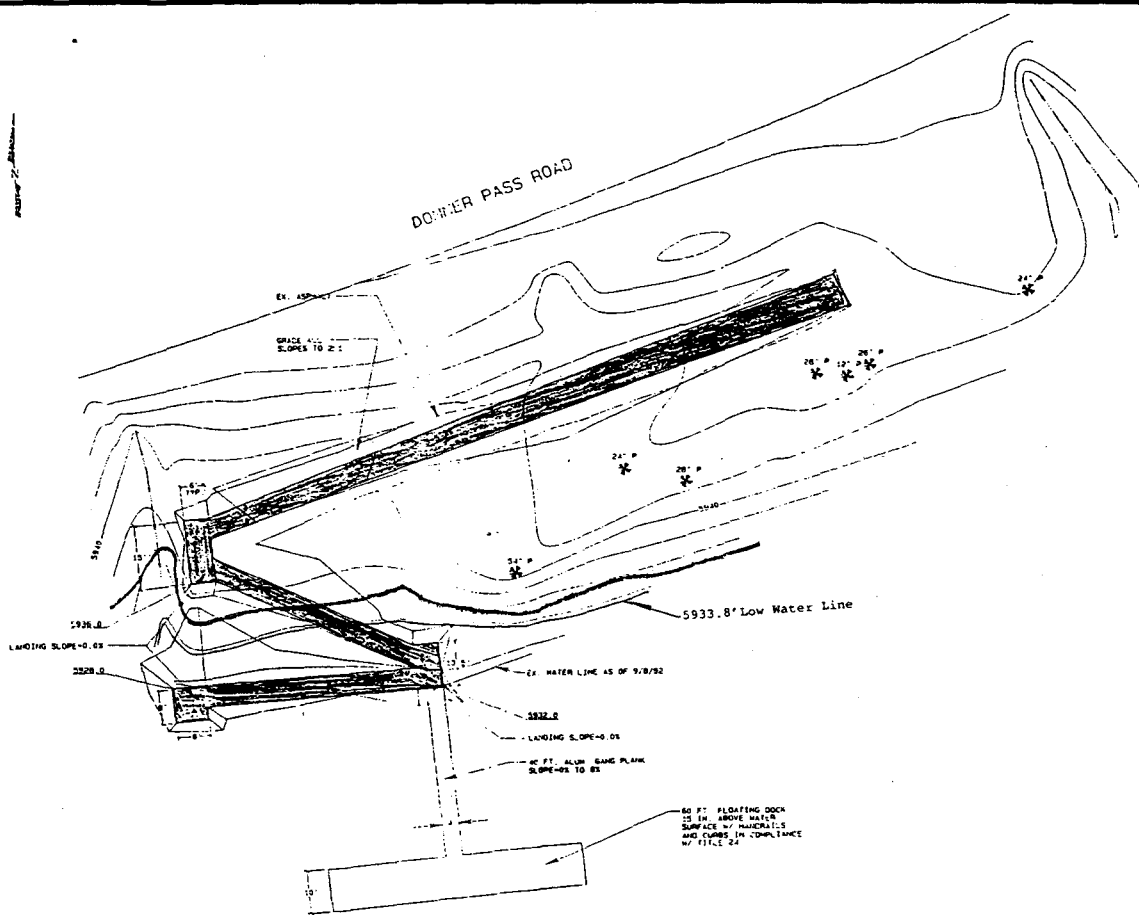
AUTHORIZATION:

AUTHORIZE THE AMENDMENT TO LEASE NO. PRC 4916.9, EFFECTIVE AUGUST 21, 1996, FOR THE CONTINUED USE AND MAINTENANCE OF ELEVEN (11) EXISTING PIERS AND THE CONSTRUCTION OF A NEW PIER WITH ACCESS FOR THE PHYSICALLY DISABLED, FOR A TOTAL OF TWELVE (12) PIERS; FOR THE STATE'S SOVEREIGN LANDS IN THE BED OF DONNER

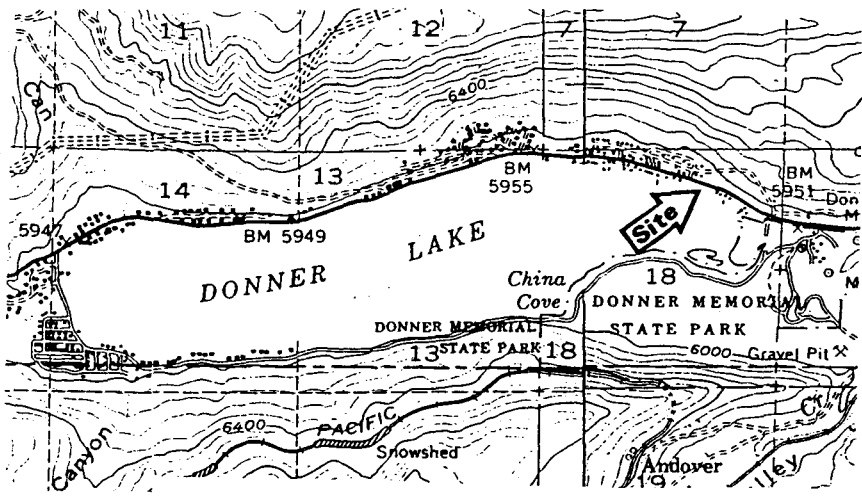


DONNER LAKE
