GENERAL LEASE - PROTECTIVE STRUCTURE AND RECREATIONAL USE

APPLICANT:

Ronald J. and Nancy J. Bain
3111 Garden Highway
Sacramento, California 95833

LOCATION:

A 0.09 acre parcel, more or less, of tide and submerged land in the Sacramento River, along the Garden Highway, Sacramento County (APN 225-200-19).

AUTHORIZED USE:

The construction of an 18 foot x 40 foot floating boat dock, a 44 inch x 60 foot ramp, and the continued use of existing bank protection.

TERM:

Ten years beginning August 1, 1996 and ending July 31, 2006.

CONSIDERATION:

Floating Boat Dock and Ramp: No consideration pursuant to Section 6503.5 of the Public Resources Code.

Bank Protection: The public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

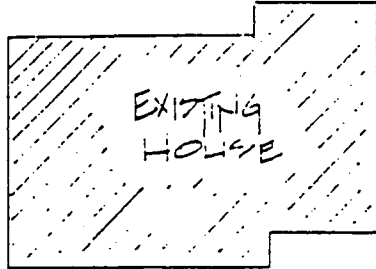
AUTHORIZATION:

BAIN OF A TEN-YEAR GENERAL LEASE - PROTECTIVE STRUCTURE AND RECREATIONAL USE BEGINNING AUGUST 1, 1996; IN CONSIDERATION OF THE FOLLOWING: FLOATING BOAT DOCK AND RAMP: NO CONSIDERATION PURSUANT TO SECTION 6503.5 OF THE PUBLIC RESOURCES CODE; BANK PROTECTION: THE PUBLIC USE AND BENEFIT WITH THE STATE RESERVING THE RIGHT TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; PROVISION OF LIABILITY INSURANCE IN THE AMOUNT OF \$500,000 COMBINED SINGLE LIMIT; FOR THE CONSTRUCTION OF AN 18 FOOT X 40 FOOT FLOATING BOAT DOCK, A 44 INCH X 60 FOOT RAMP, AND THE CONTINUED USE OF EXISTING BANK PROTECTION; ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

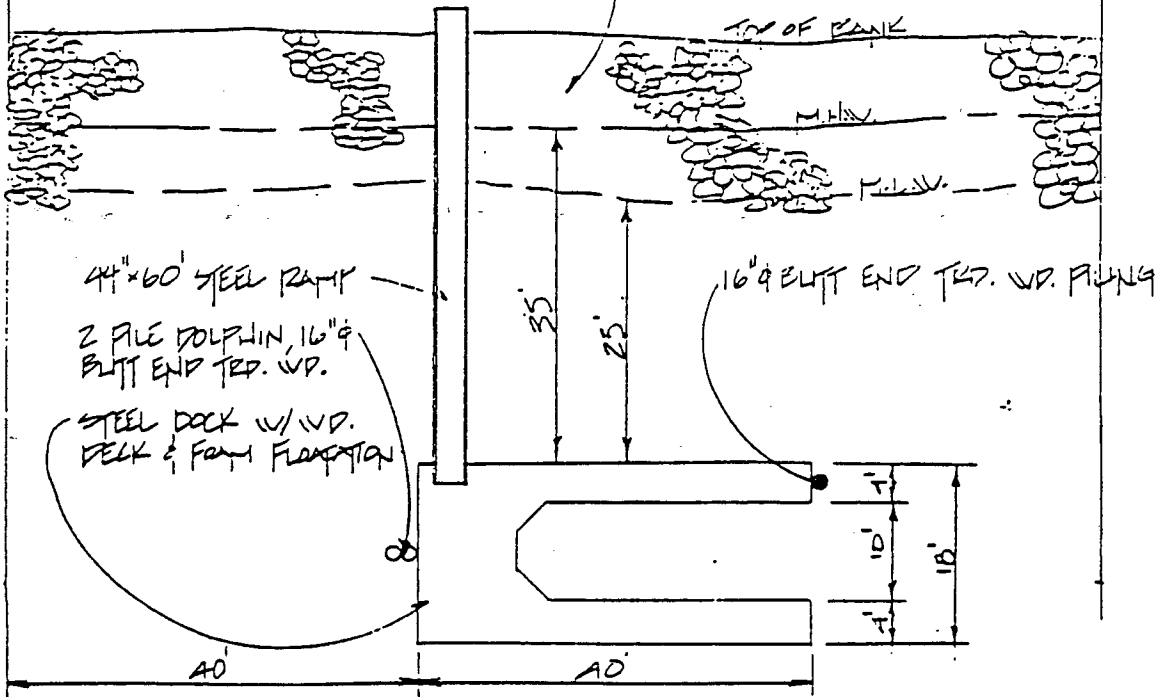

APPROX. 250 CU. YDS. OF RIP-RAP TO BE ADDED



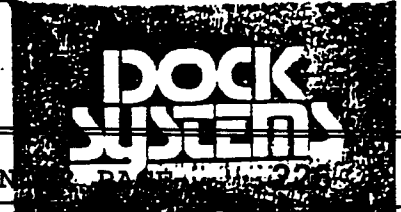

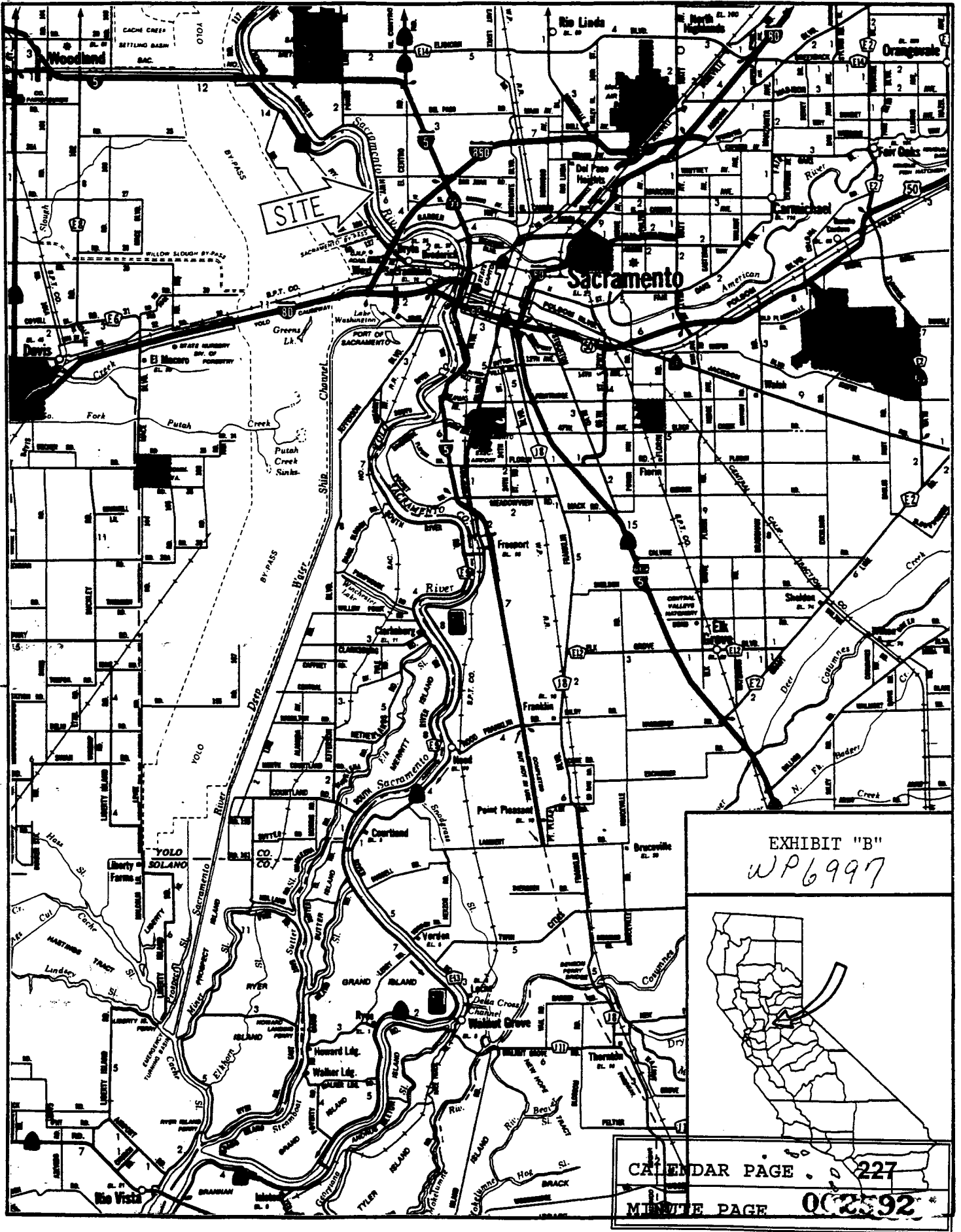
