**CONSIDER SETTLEMENT AGREEMENT IN CASE OF
MILLAR v. STATE OF CALIFORNIA
GLENN COUNTY SUPERIOR COURT NO. 29584**

BACKGROUND:

The Office of the Attorney General, acting on the behalf of the State, and subject to Commission approval, has negotiated a settlement of quiet title litigation involving certain lands owned by the Commission near the Sacramento River in Glenn County. The Commission's Title and Boundary Units have reviewed the proposed property descriptions to be quieted and are satisfied that they do not adversely affect the sovereign interests of the State.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THIS ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY PUBLIC RESOURCES CODE SECTION 21065 AND 14 CAL. CODE REGS. 15378.
2. AUTHORIZE STAFF AND THE OFFICE OF THE ATTORNEY GENERAL TO COMPLETE THE SETTLEMENT IN THE CASE OF MILLAR V. STATE OF CALIFORNIA, GLENN COUNTY SUPERIOR COURT NO. 29584. PROVIDED THAT THE FINAL SETTLEMENT INCLUDES THE PROPERTY DESCRIPTION WHICH HAS BEEN APPROVED BY THE COMMISSION'S BOUNDARY AND TITLE UNITS.
3. AUTHORIZE STAFF AND THE OFFICE OF THE ATTORNEY GENERAL TO TAKE ALL STEPS NECESSARY, INCLUDING ANY REQUIRED COURT APPEARANCES, TO IMPLEMENT THE SETTLEMENT.
