**REVISION OF RENT**

**LESSEE:**

Estate of Naomie King  
Attn: Wilfred O'Neill, Administrator  
226 Paso Nogal  
Pleasant Hill, California 94523

**AREA, LAND TYPE, AND LOCATION:**

0.13 acres, more or less, of tide and submerged lands in the bed of Old River at King's Island, Contra Costa and San Joaquin counties.

**AUTHORIZED USE:**

A 30-foot long x 15-foot wide bridge structure and a road easement 260 feet in length x 20 feet wide.

**LEASE TERM:**

30 years, beginning January 1, 1986.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$607.68 per year to \$693 per year, effective January 1, 1997.

The recommended adjustment of rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). Application of the CPI to adjust rents at this time is an interim measure necessitated by budget constraints and resultant losses in staff, and does not obligate the Commission to use of the CPI to adjust rentals other than as specifically set forth herein.
