RECREATIONAL PIER LEASE

LESSEE:

R. Daniel Putman and Kathleen L. Williams
754 De Soto
Palo Alto, California 94303

AREA, LAND TYPE, AND LOCATION:

A parcel of submerged lands in Lake Tahoe, Meeks Bay Vista, El Dorado
County.

AUTHORIZED USE:

Pier/boat lift repair and modification, and two existing mooring buoys.

LEASE TERM:

Ten years, beginning January 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

This lease is conditioned on the Lessee obtaining authorization from the Tahoe
Regional Planning Agency for the existing mooring buoys within two years from
the effective date of the authorization of the buoys by the Commission.

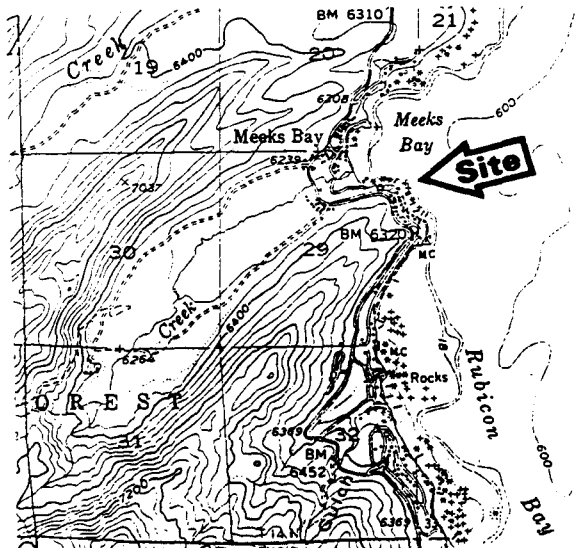

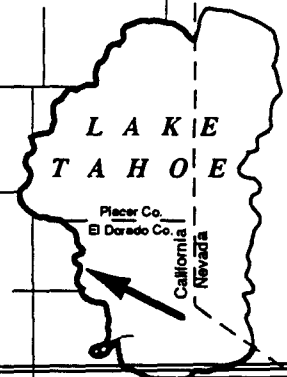

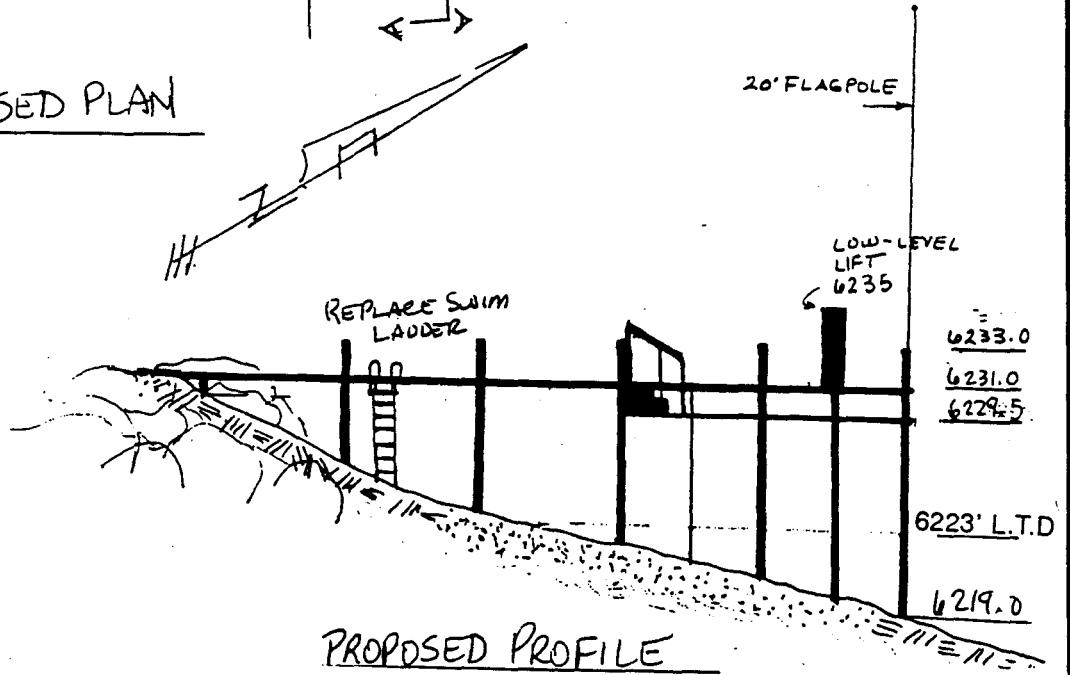

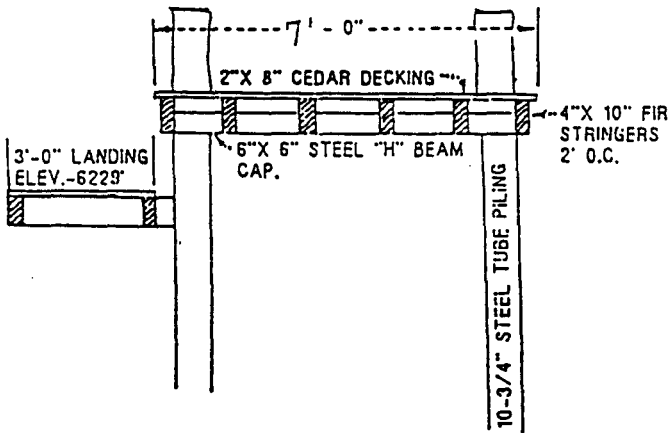


PROPOSED PLAN

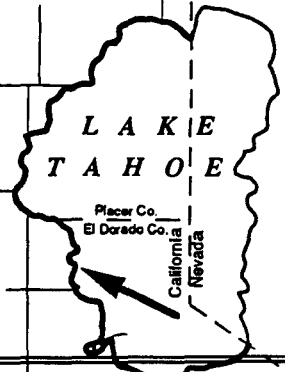

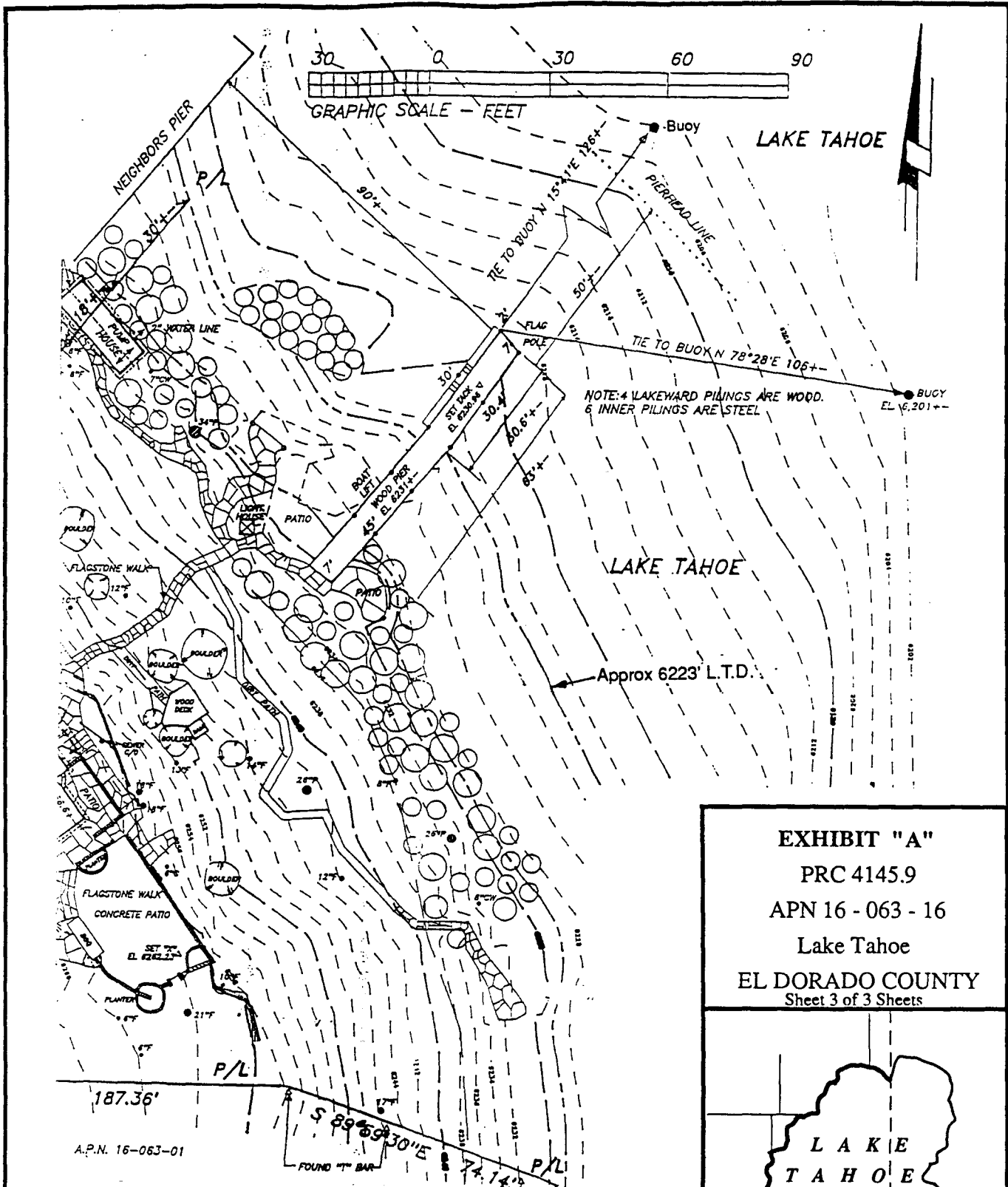
