AMENDMENT OF LEASE

LESSEE:

ARCO Pipeline Company
P. O. Box 787
Long Beach, California 90805

AREA, LAND TYPE, AND LOCATION:

9.72 acres, more or less, of school lands located in Section 36, T9N, R20E,
SBM, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of a 16" crude oil pipeline.

LEASE TERM:

49 years, beginning September 19, 1957.

CONSIDERATION:

\$1,059.30 total rent for the full term of 49 years.

PROPOSED AMENDMENT:

Land Use:

Construct and maintain, within the existing 60' right-of-way easement, a
Cathodic Protection Unit (CPU) in order to protect the existing 16" crude
oil pipeline from external corrosion.

Improvements:

The CPU consists of the following improvements: 24' x 24' fenced
enclosure, deep well anode ground bed, one 1,000-gallon diesel fuel tank,
one 14-break horse powered diesel generator, and underground electrical
cables.

All other terms and conditions of the lease will remain in effect without
amendment.

CALENDAR ITEM NO. C20 (CONT'D)

OTHER PERTINENT INFORMATION:

1. Pursuant to the terms of Lease No. PRC 2001.2, no substantial alterations to the existing structures or erection of new structures will be completed without the prior written consent of the Commission. Staff reviewed the CPU plans and determined that due to the nature and extent of the proposed CPU improvements, ARCO must apply for a lease amendment in order to install the CPU.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes based on the information available to it, that there is no possibility that this project may have a significant effect on the environment.

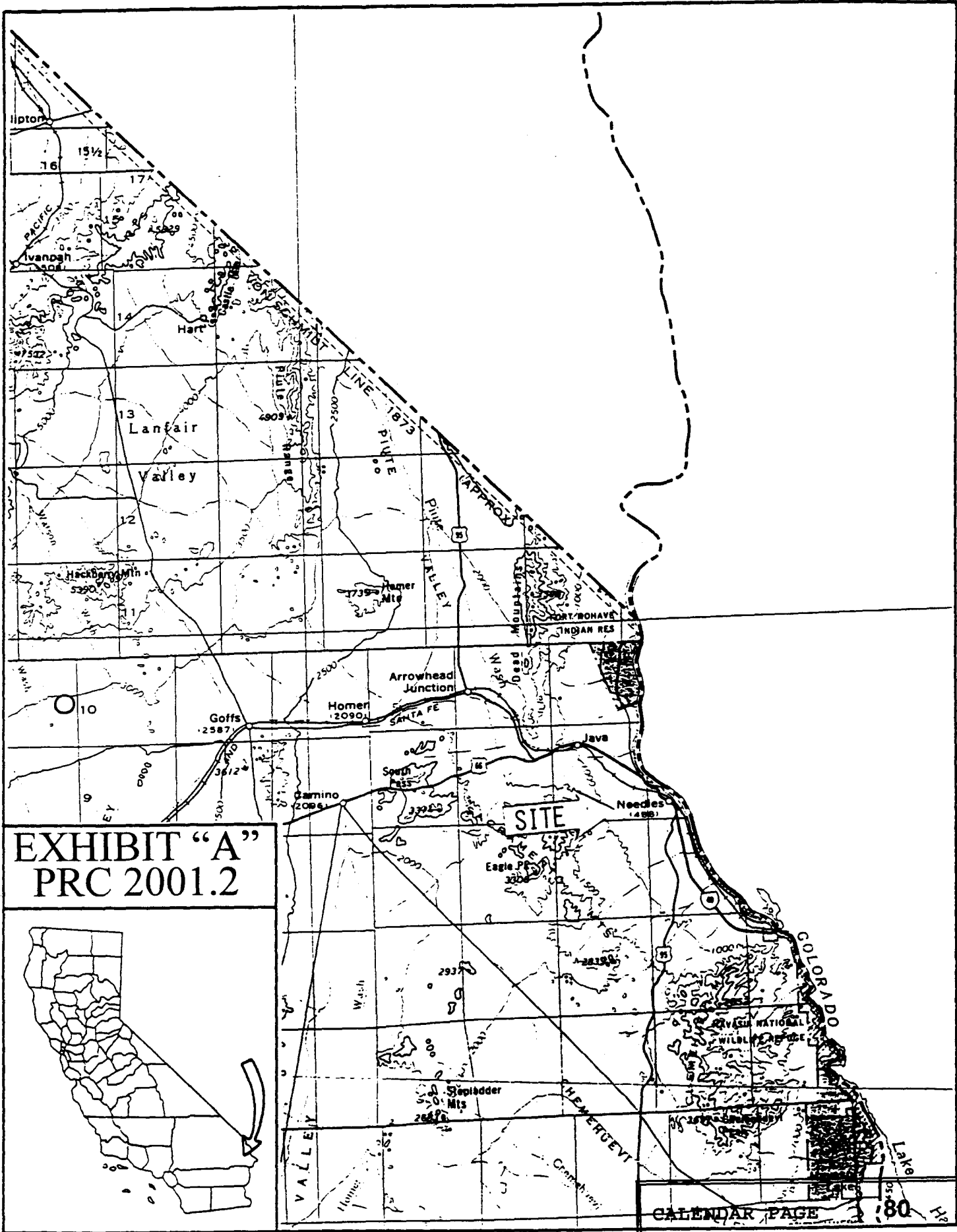
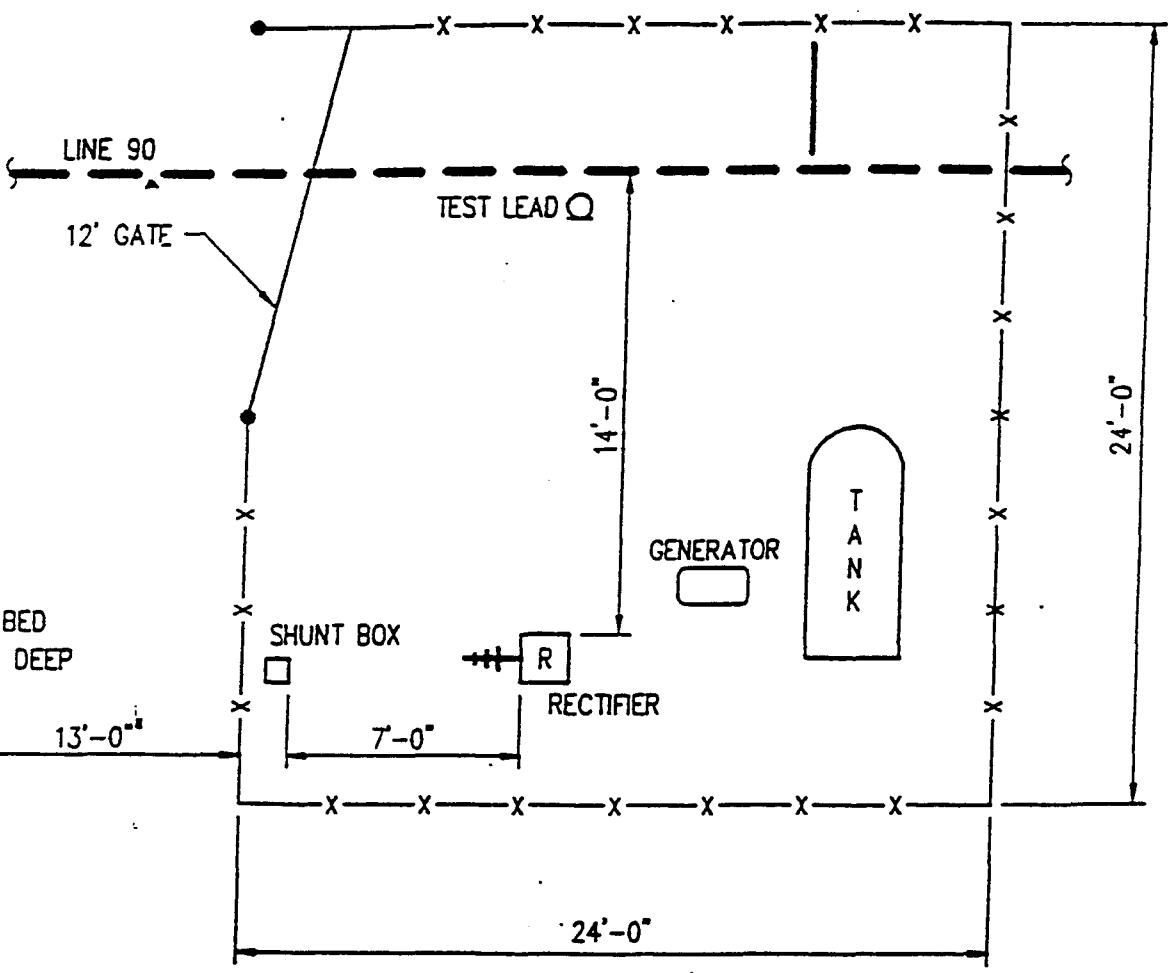
