**LEASE TERM:**

Ten years, beginning February 1, 1997.

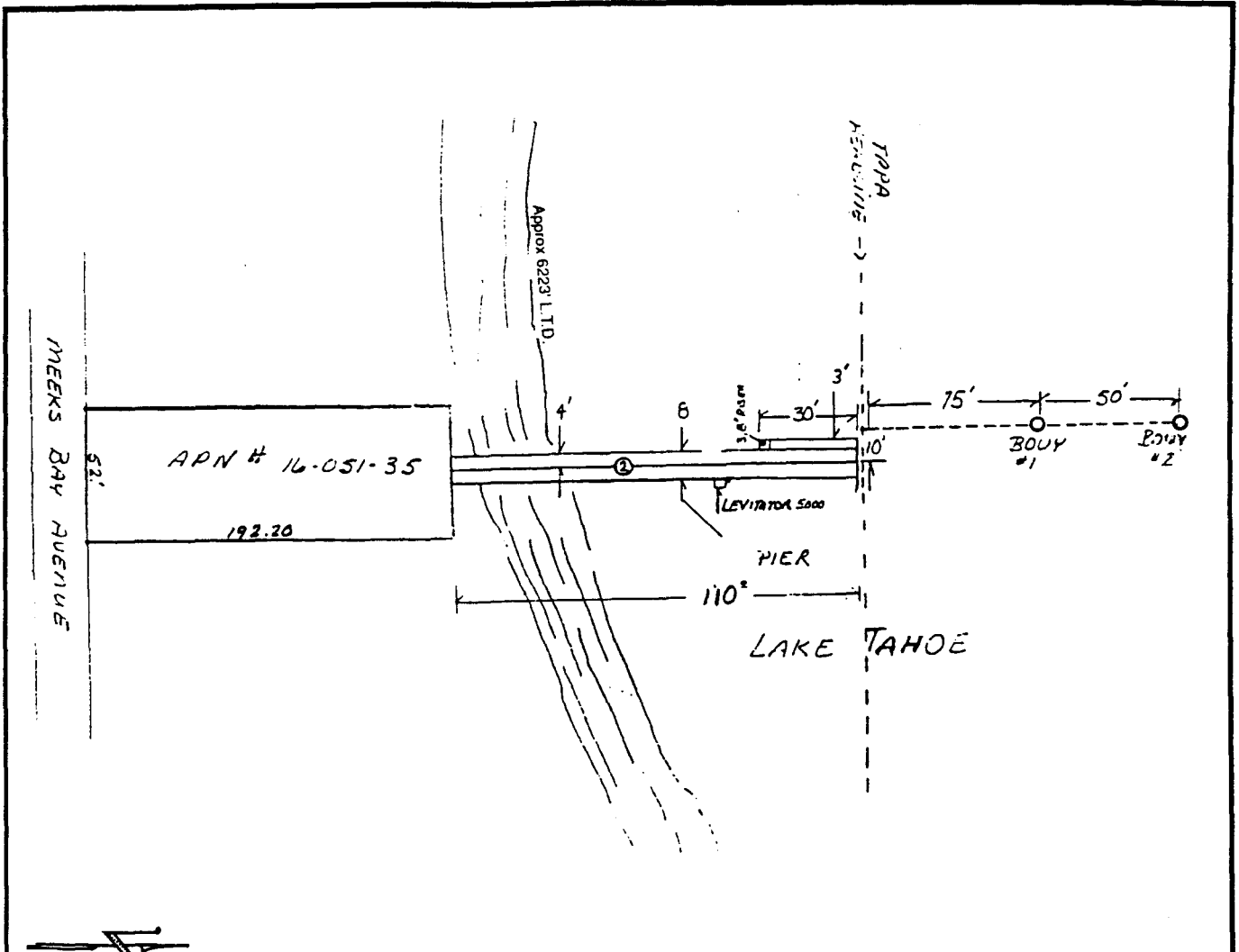

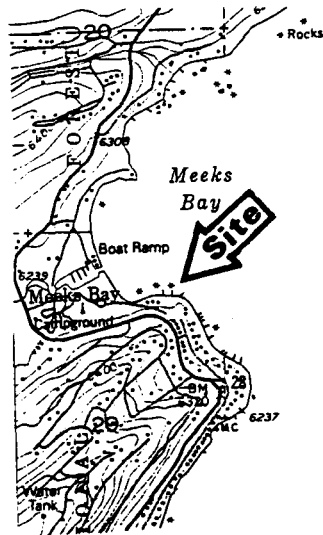

Lake Tahoe

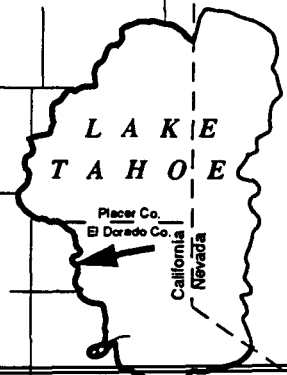
