**ISSUANCE OF A PATENT FOR  
SWAMP AND OVERFLOWED LANDS SURVEY NO. 88  
HUMBOLDT COUNTY**

**BACKGROUND**

Domingo Santos and Mary Lou Santos have requested that a State Swamp and Overflow Patent be issued for a 40 acre parcel of swamp and overflow lands in Humboldt County. An application for purchase of the parcel was made on June 25, 1860 and approved on June 28, 1860. The Certificate of Purchase 654 was paid in full on July 28, 1860 and was issued on November 29, 1861. The original certificate of purchase is beyond on the control of the present owners of the land (applicants). An affidavit pursuant to Public Resources Code section 7729 has been executed by the applicants. No patent has yet been issued to complete the chain of title on the parcel.

Staff has examined the file and other information submitted by First American Title Company and has concluded that the laws relating to the issuance of a patent for the described lands have been complied with, and the person to be named in the patent (Charles Liscom) is entitled to it. Domingo Santos and Mary Lou Santos are the successors-in-interest to Charles Liscom.

2. FIND THAT THE LAWS IN RELATION TO THE ISSUANCE OF A STATE PATENT HAVE BEEN COMPLIED WITH; THAT PAYMENT IN FULL HAS BEEN MADE; THAT AN AFFIDAVIT HAS BEEN RECEIVED; AND THAT THE PERSON NAMED IN THE PATENT (CHARLES LISCOM) IS ENTITLED TO IT.
3. AUTHORIZE STAFF AND THE OFFICE OF THE ATTORNEY GENERAL TO PREPARE AND PROCESS A STATE PATENT TO BE ISSUED IN THE NAME OF CHARLES LISCOM FOR THE NE¼ OF THE SE¼ OF SECTION 25, TOWNSHIP 6 NORTH, RANGE 1 WEST, H. B. & M. CONTAINING 40 ACRES MORE OR LESS OF STATE SWAMP AND OVERFLOW LANDS IN HUMBOLDT COUNTY AND EXCEPTING OUT ANY SOVEREIGN INTEREST IN SUCH LANDS.
