RECREATIONAL PIER LEASE

APPLICANT:

AREA, LAND TYPE, AND LOCATION:

0.05 acres, more or less, of tide and submerged land located in Threemile Slough (APN 158-0010-024), Sherman Island, Sacramento County.

AUTHORIZED USE:

Covered single-berth floating dock with metal gangway as shown on attached Exhibit A.

LEASE TERM:

Ten years, beginning April 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of \$300,000.

OTHER PERTINENT INFORMATION:

- Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061) the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures, Title 2, California Code of Regulations, section 2905(c)(1).

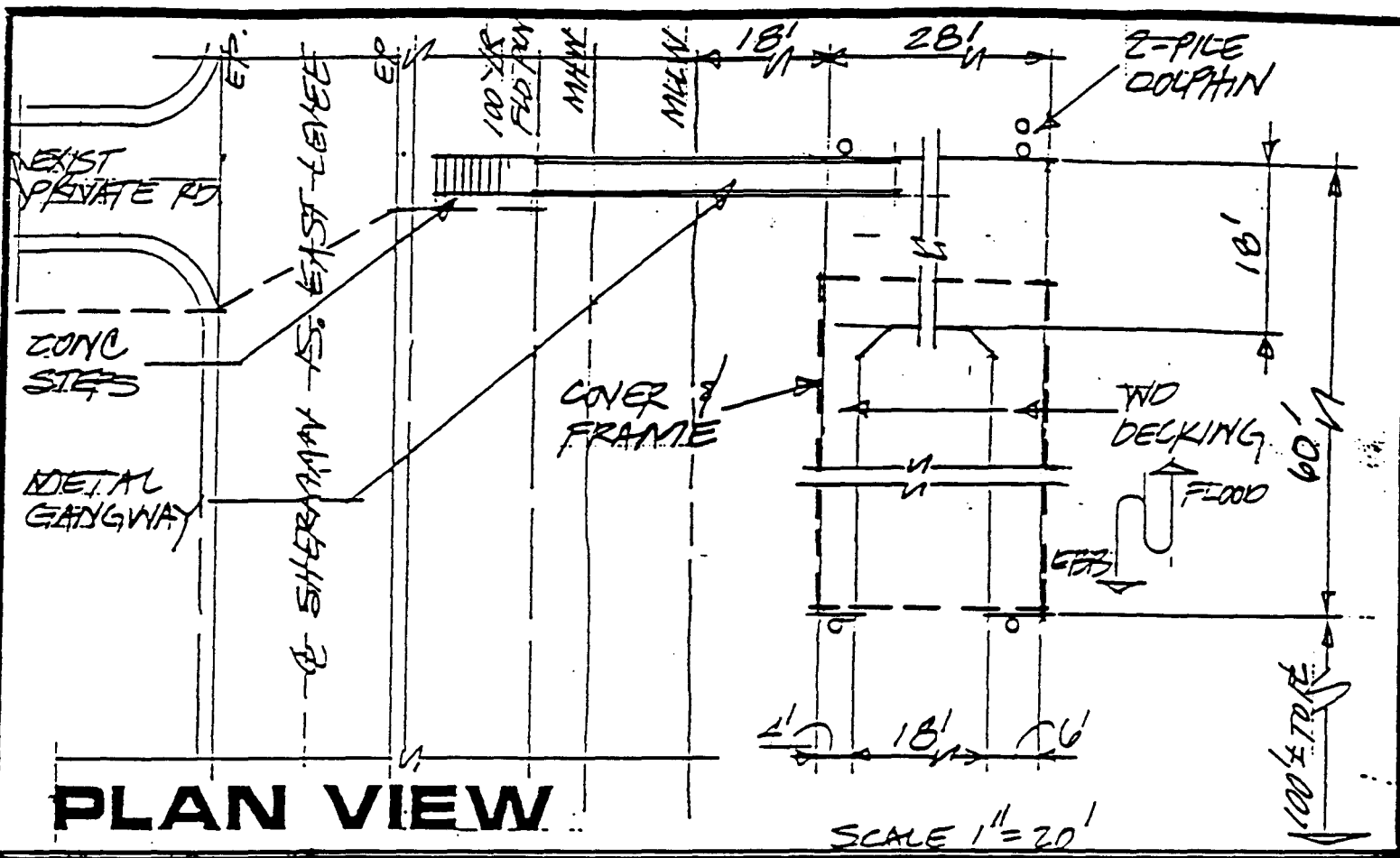

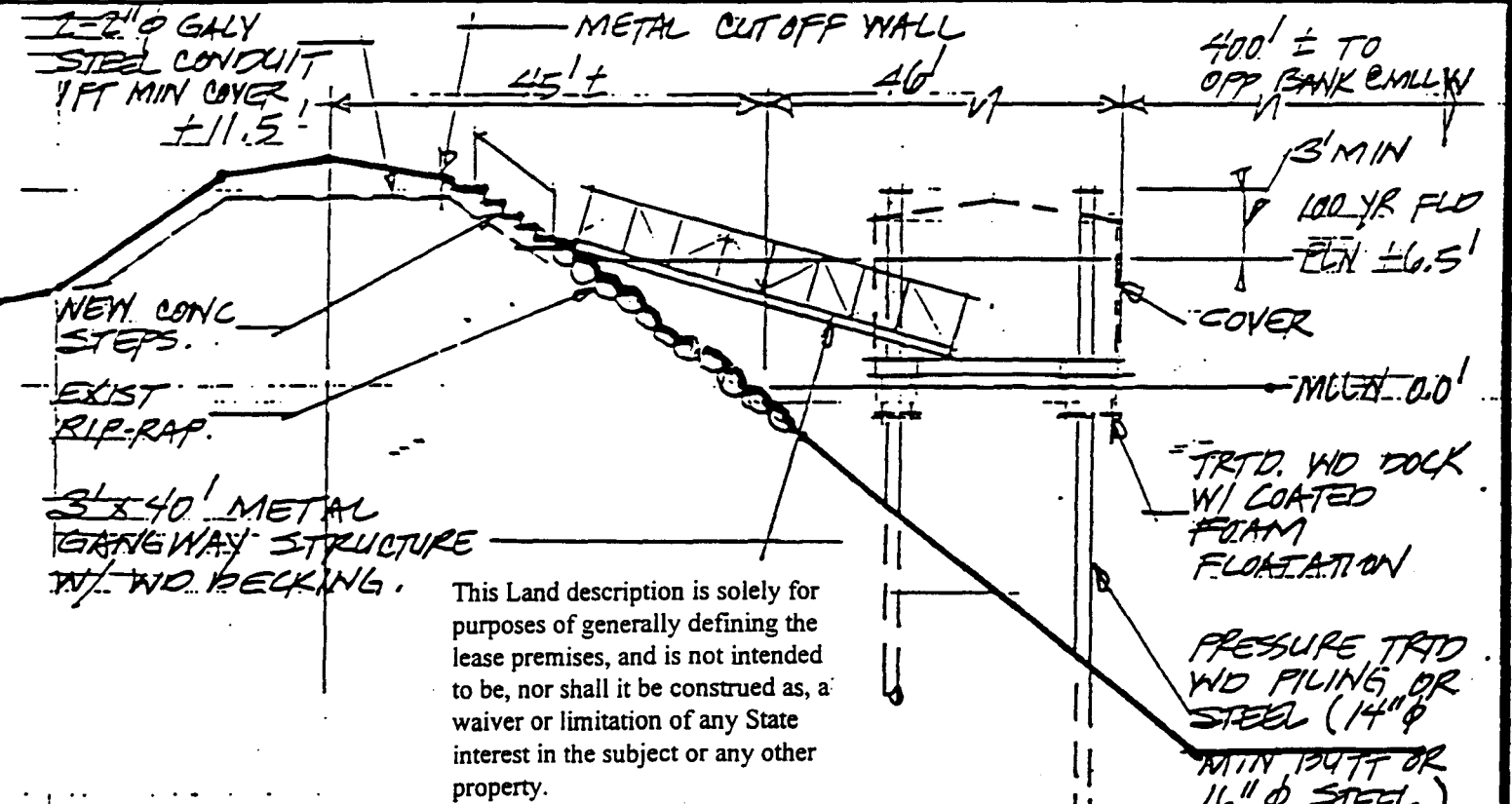

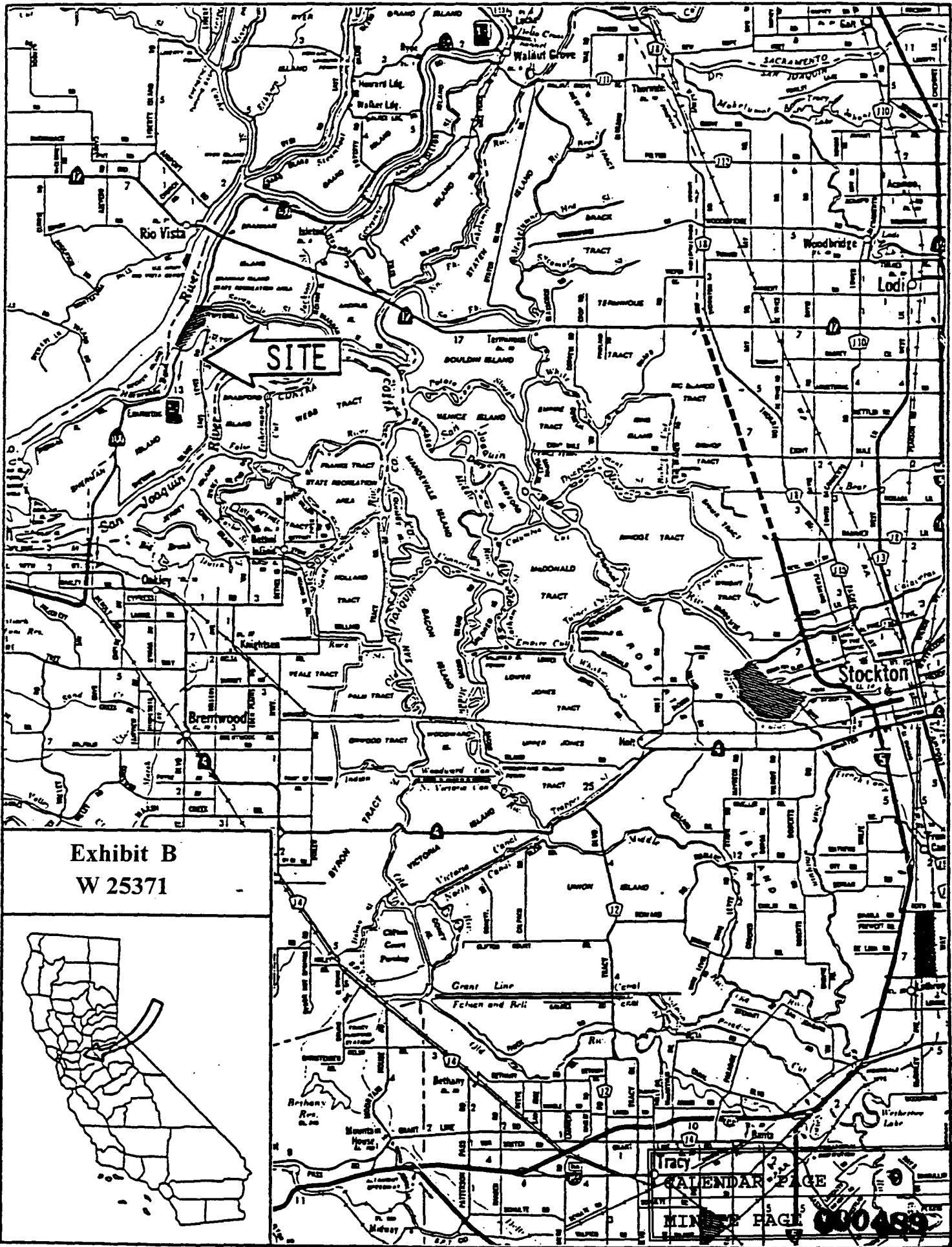
