RECREATIONAL PIER LEASE

LESSEE:

Gerald V. and Kerri A. Hansen
30 Pecetti Circle
Reno, Nevada 89511

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Carnelian Bay, Placer County.

AUTHORIZED USE:

Pier replacement, installation of a boat lift and addition of one existing mooring buoy, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning April 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

1. Insurance:
Liability insurance in the amount of no less than \$300,000.
2. The lease is conditioned on lessee's obtaining authorization from the Tahoe Regional Planning Agency for the existing buoys within two years of the authorization of the buoys by the Commission.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as categorically exempt projects.

The pier is exempt under Class 2, Replacement or Reconstruction, Title 14, California Code of Regulations, section 15302. Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

The boat lift is exempt under Class 3, New Construction of Small Structures, Title 14, California Code of Regulations, section 15303 (3). Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

The buoy is exempt under Class 3, New Construction of Small Structures, Title 2, California Code of Regulations, section 2905 (c) (3). Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

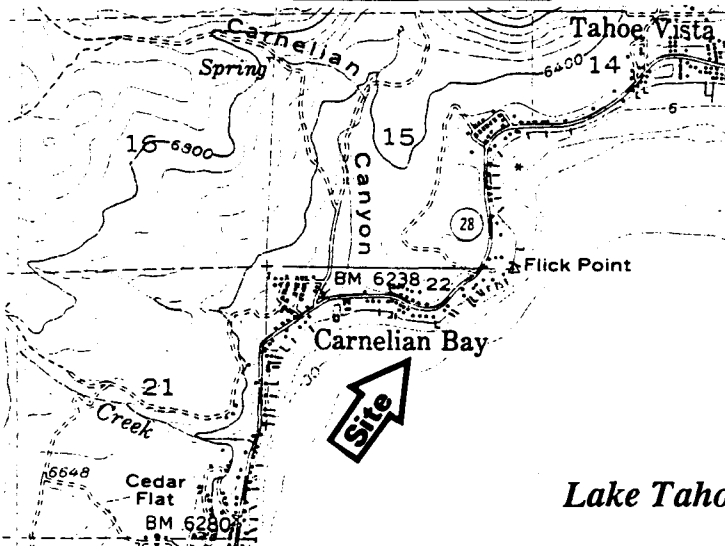

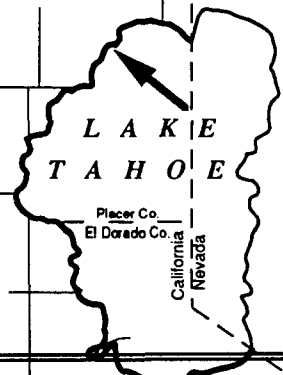

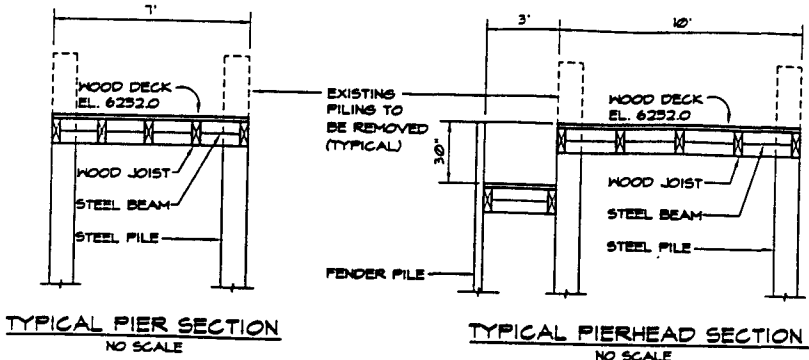

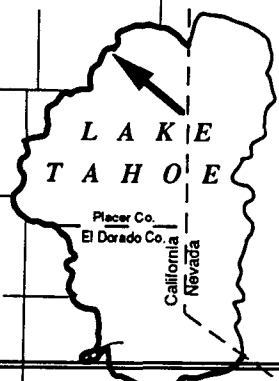
