GENERAL LEASE - GRAZING USE

APPLICANT:

Roy Hunter P. O. Box 26 Olancha, California 93549

AREA, LAND TYPE, AND LOCATION:

127 acres, more or less, of lieu lands and 72 acres, more or less, of sovereign lands on the west side of Owens Lake, near the town of Olancha, Inyo County.

AUTHORIZED USE:

Cattle grazing.

LEASE TERM:

Two years, beginning December 13, 1995, and ending December 12, 1997.

CONSIDERATION:

\$500 per year.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. The applicant has a right to use the lands that adjoin the lease premises.
- 2. During the lease application process, California State Lands Commission (CSLC) staff consulted with staff of the California Department of Fish and Game (CDFG). CDFG staff subsequently conducted a field survey of the proposed lease area and identified potential impacts to a variety of sensitive species and habitats affecting portions of the proposed lease area.

- 3. Upon completion of the field survey, CDFG concluded that since the applicant has grazed the area in the past and since half of the grazing season is now complete, they would not object if the CSLC issued a lease to the applicant to cover another Fall grazing season.
- 4. Based on information provided by CDFG, CSLC staff recommends issuing a two-year grazing lease effective December 13, 1995, that would allow the applicant to graze through the 1997 Fall grazing period only.
- 5. CSLC staff have advised the applicant that a grazing plan must be developed and additional environmental analysis must be conducted before the Commission would consider issuing a long-term grazing lease.
- 6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
- 7. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 2, California Code of Regulations section 2905(d)(1).


