RECREATIONAL PIER LEASE

APPLICANT:

Sloss Tahoe Property, A California General Partnership
Attn.: Anthony Sloss
192 Fast Lane
Santa Cruz, California 95065

AREA, LAND TYPE, AND LOCATION:

Submerged lands in Lake Tahoe near Tahoma, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and one mooring buoy, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning March 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

1. Insurance:
Liability insurance with coverage of no less than \$300,000.
2. The lease is conditioned on lessee's obtaining authorization from the Tahoe Regional Planning Agency for the existing buoy within two years of the authorization of the buoy by the Commission.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations,
