**AREA, LAND TYPE, AND LOCATION:**

.99 acres, more or less, of tide and submerged lands in Steamboat Slough, at Martin's Island (APN 048-260-120), Solano County.

**AUTHORIZED USE:**

A marina, consisting of floating docks, platforms, launch ramp, gas dock, and necessary pilings.

**LEASE TERM:**

20 years, beginning September 23, 1988.

**CONSIDERATION:**

\$1,575 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the uplands adjoining the lease premises.

**LAND DESCRIPTION**

Those parcels of tide and submerged land in the bed of Steamboat Slough, Solano County, State of California, more particularly described as follows:

All that tide and submerged land lying immediately beneath 12 docks and related facilities, said docks and related facilities lying within a strip of land of varying width 1410 feet in length adjacent to the easterly side of the southerly half of Martin's Island, being bounded on the west by the ordinary high water mark of Steamboat Slough and on the north by the southeasterly extension of that certain course identified as N 72°15'30" W 76.30 feet as said course is shown on that certain map entitled, "Resurvey of S&O 544" recorded in Book 7 of Surveys at Page 63, Solano County Recorder's Office; said strip containing those 12 existing or proposed docking facilities as shown on U.S. Corps of Engineer's Public Notice No. CE SAC 87-7451A TOGETHER WITH the necessary use areas extending 10 feet from the extremities of said docking facilities.

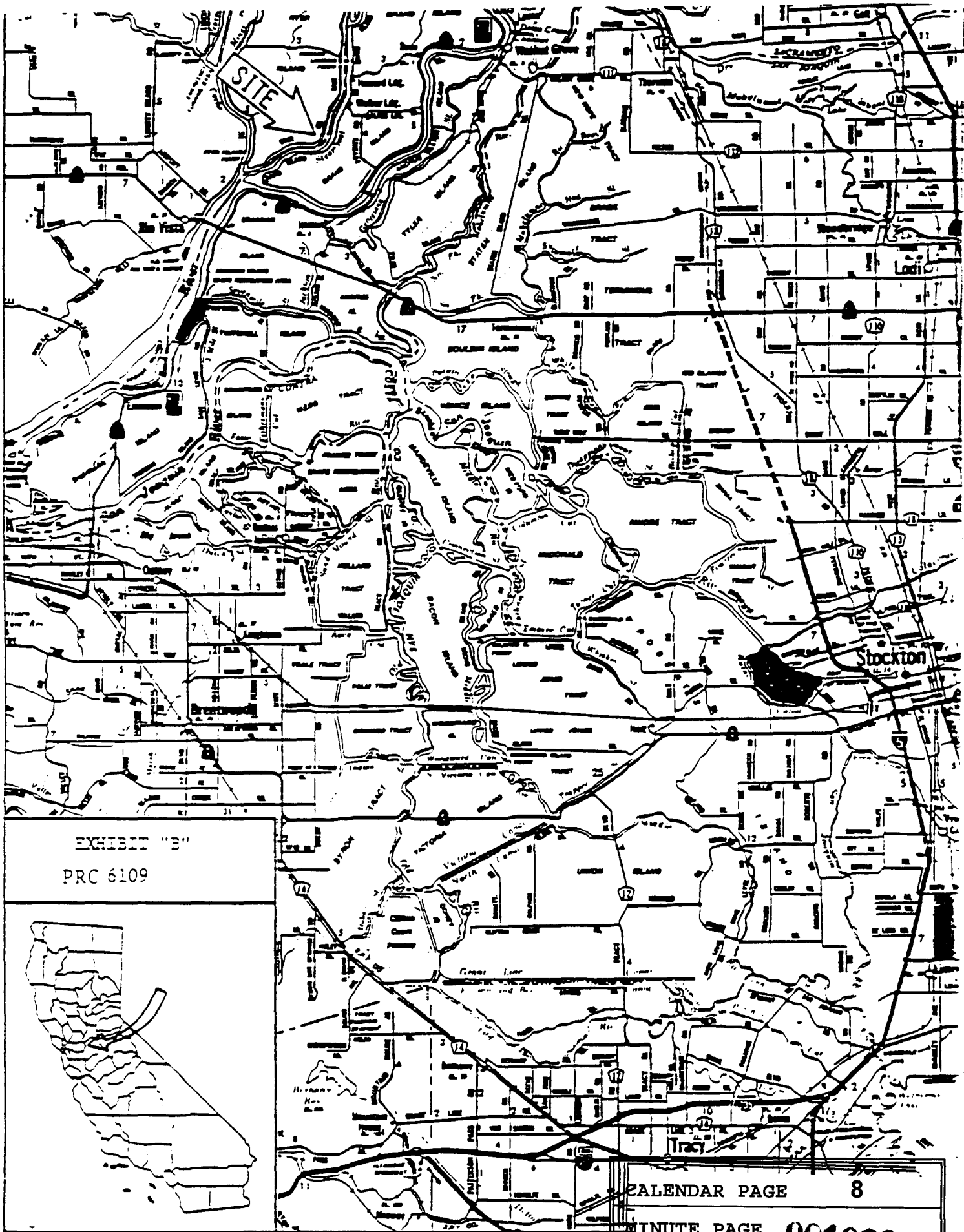
