RECREATIONAL PIER LEASE

APPLICANT:

Woodrow A. Hahn and Charlotte M. Hahn, Trustees of the Woodrow A. Hahn and Charlotte M. Hahn 1977 Revocable Intervivos Trust, as Amended; Michael P. Garton and Beverley J. Garton
1840 Capitol Street, Suite A
Vallejo, California 94590

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Homewood, Placer County.

AUTHORIZED USE:

Modification, use and maintenance of an existing pier, boat lift and two mooring buoys, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning June 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

The lease is conditioned on lessee obtaining authorization from the Tahoe Regional Planning Agency for the buoys within two years from the effective date of the authorization of the buoys by the Commission.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project.

The pier repair is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations section 2905 (a) (2). Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

The boat lift and mooring buoys are exempt under Class 3, New Construction of Small Structures; Title 14, California Code of Regulations, section 15303 (e). Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300, and Title 2, California Code of Regulations, section 2905 (c) (3).

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

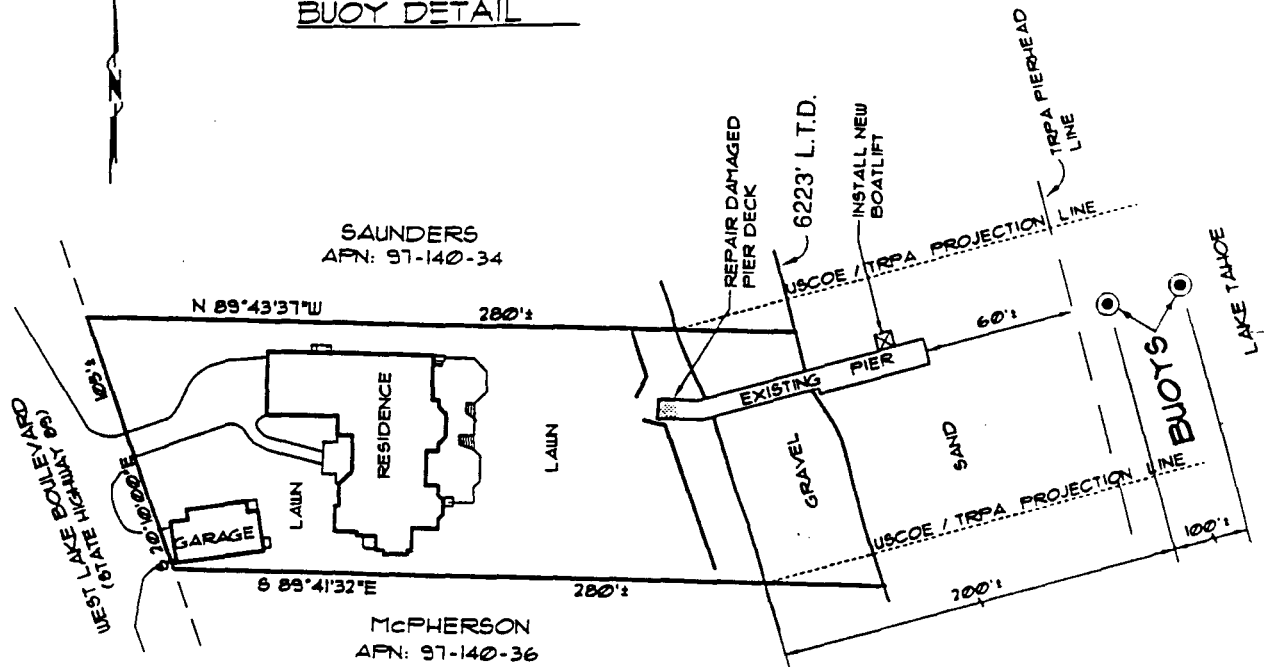

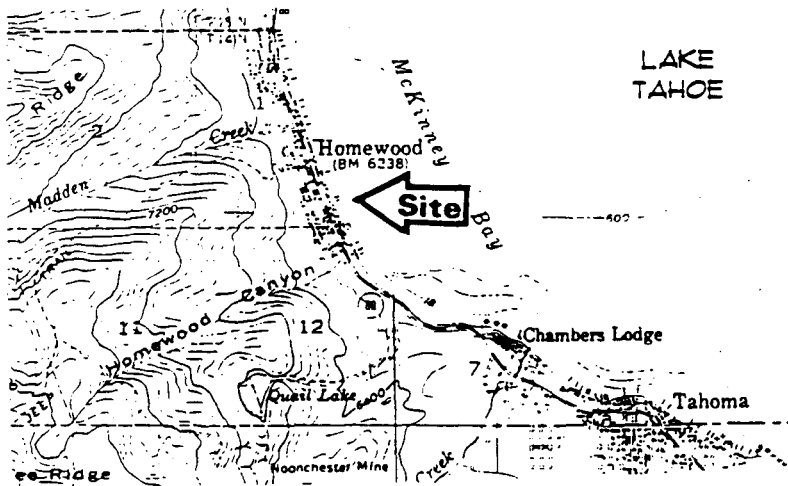

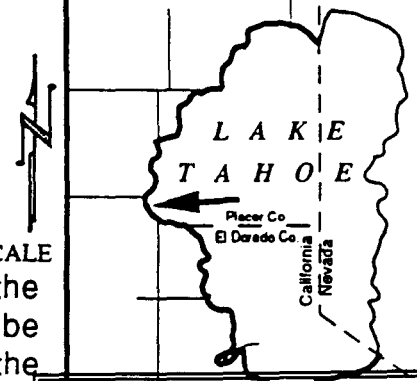
LOCATION MAP

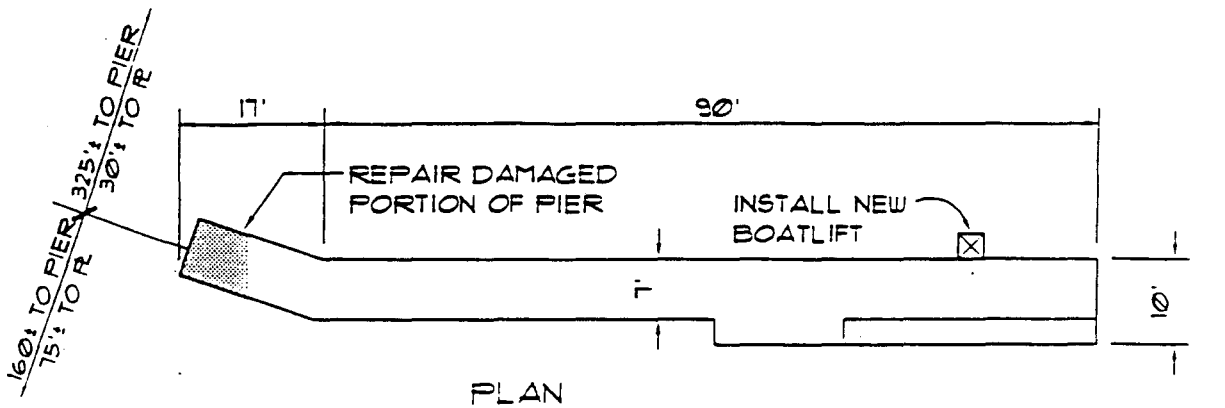

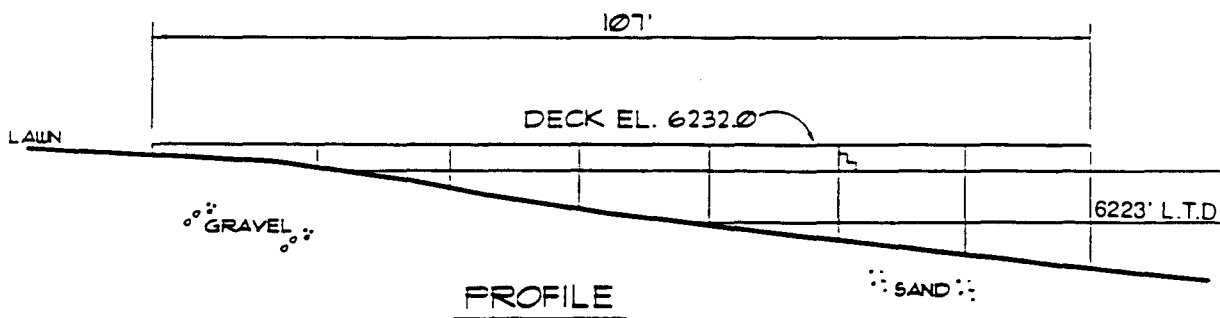

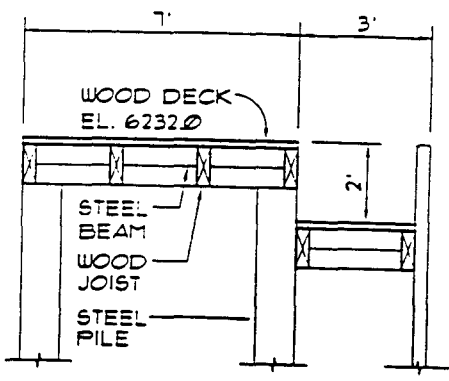

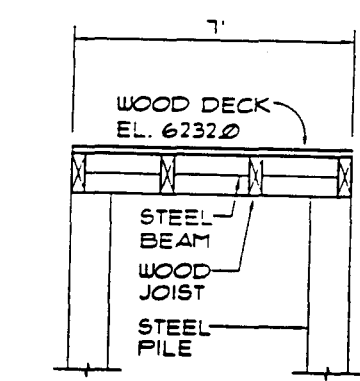

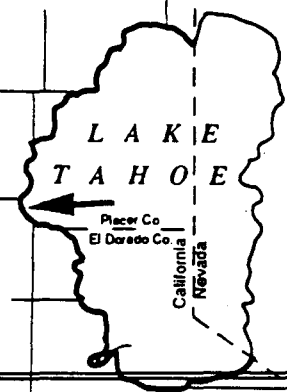


TYPICAL PIERHEAD SECTION
