GENERAL LEASE - RECREATIONAL USE

LESSEE:

Young Men's Christian Association of Glendale 140 North Louise Street Glendale, California 91206-4226

AREA, LAND TYPE, AND LOCATION:

3.8 acres, more or less, of sovereign lands in White Cove near White's Landing on the northeast shore of Santa Catalina Island, Los Angeles County.

AUTHORIZED USE:

Continued use and maintenance of existing recreational facilities that consist of one standing pier, one ramp attached to the pier, one landing float, one swim float, one swim area with swim line marker, two rowboat mooring string lines, four full size moorings, and one ski boat platform.

LEASE TERM:

Ten years, beginning January 1, 1991.

CONSIDERATION:

\$50 per year; plus the public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Combined single limit liability insurance coverage of \$3,000,000.

OTHER PERTINENT INFORMATION:

1. The Applicant has submitted an application to replace an existing General Lease - Recreational Use, that expired December 31, 1991. The replacement lease provides for the continued use of sovereign lands for the use and maintenance of existing recreational facilities in White Cove which are used in conjunction with the Applicant's upland camp facility. Back rent in the amount of \$350 has been paid by the Applicant.

- 2. Applicant has the right to use the uplands adjoining the lease premises.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


