RECREATIONAL PIER LEASE

APPLICANT:

Gary Lee Groves, M.D., Trustee of The Groves Family Trust October 4, 1988
1638 Garden Street
Redlands, California 92373

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Pacific Ocean, near Laguna Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of existing recreational pier, as shown on attached Exhibit A.

LEASE TERM:

Ten years, beginning August 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project, Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).

Authority: Public Resources Code, section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

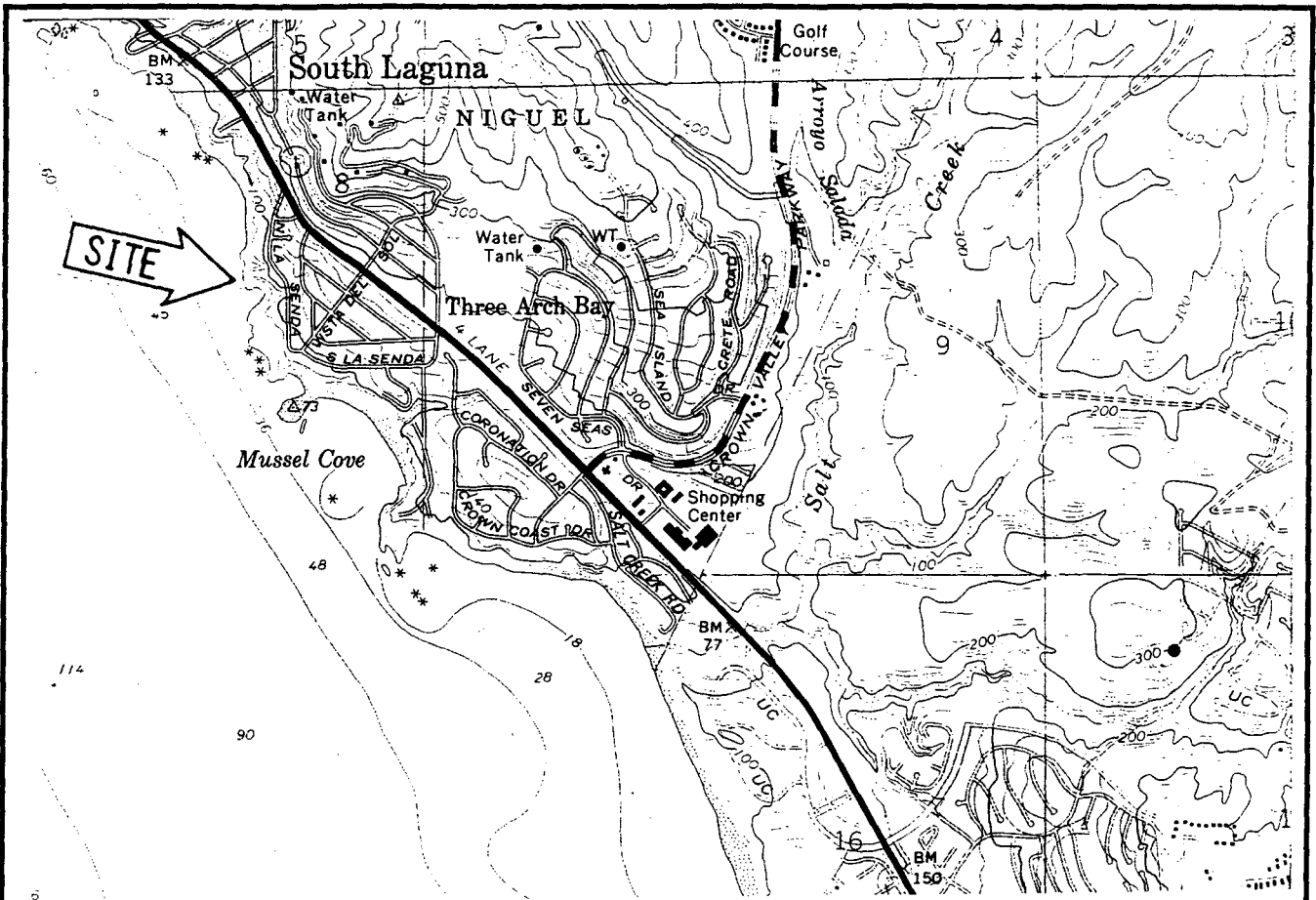

NOT TO SCALE

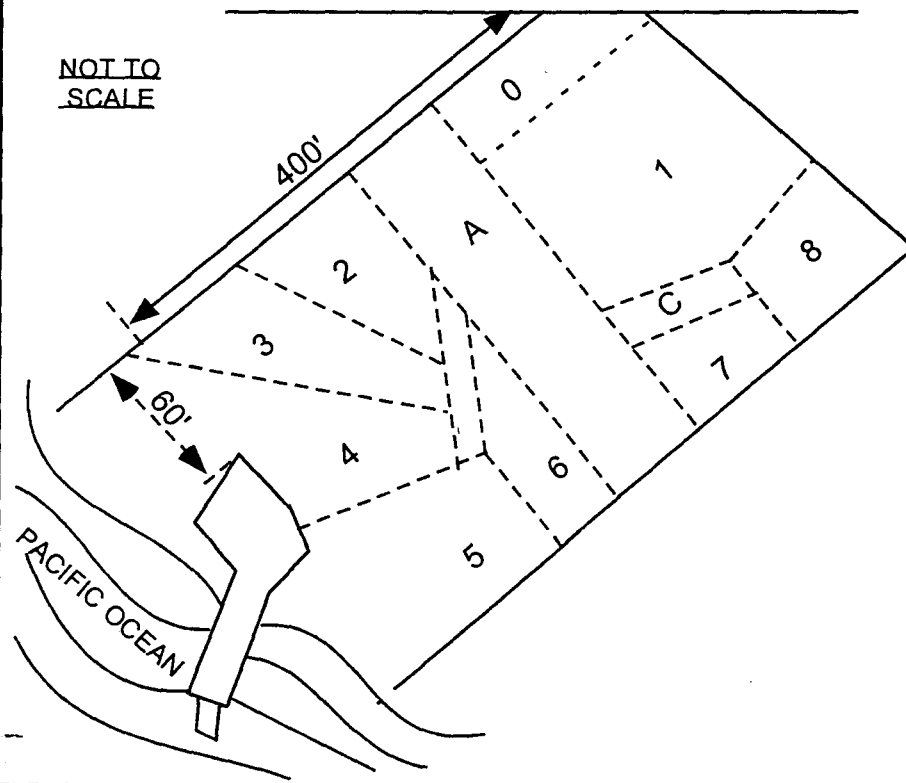
