#### OTHER PERTINENT INFORMATION

On October 17, 1995, the Commission authorized the Staff to apply for and, if granted, expend funds from the Hazard Mitigation Grant Program managed by the Federal Emergency Management Agency (FEMA). Those funds were being made available through the Office of Emergency Services (OES) and FEMA to mitigate the effects of future earthquakes. Staff's purpose in pursuing these resources has been to develop regulations and guidelines establishing design criteria to respond to seismic ground motion and soil liquefaction and addressing fire detection and suppression for both new and existing marine oil terminals

throughout the State. Seismic hazard information for port areas in Southern California would also be compiled to be used in implementation of those regulations and guidelines.

The application has now been approved by FEMA and OES. Staff now requests that it be delegated authority to solicit bids for services in developing the subject information and criteria.

#### IT IS RECOMMENDED THAT THE COMMISSION:
