**CONSIDER APPROVAL OF NATURAL GAS  
PURCHASE AND SALES AGREEMENT,  
OIL AND GAS LEASE NO. E-415.1  
SACRAMENTO COUNTY**

**AREA, LAND TYPE, AND LOCATION:**

Oil and Gas Lease No. E-415.1 consists of 24 acres of tide and submerged lands under Three Mile Slough, Rio Vista Area, Sacramento County.

**BACKGROUND:**

Chevron U.S.A. is the lessee and operator of Oil and Gas Lease No. E-415.1. This lease was issued on June 3, 1940. Chevron currently has a Gas Purchase and Sales Agreement with Pacific Gas and Electric (PG&E) which it has elected to terminate pursuant to recent changes in the California Public Utility Commission regulations. In place of this agreement, Chevron plans to market natural gas produced from Oil and Gas Lease No. E-415.1 under a Master Gas Sales Contract with Natural Gas Clearinghouse. The contract term is 10 years with a five year option to extend. The Commodity Price paid by Natural Gas Clearinghouse to Chevron U.S.A. under this contract for each MMBtu of committed gas delivered to Natural Gas Clearinghouse shall be based on prevailing index prices reported in the Gas Daily, will change each month, and will vary by source of supply and delivery point. It will include premiums, if any, and deductions for gathering and transportation charges. Pursuant to Section 2(f) of Oil and Gas Lease No. E-415.1, Chevron requests Commission approval of this new Natural Gas Purchase and Sales Agreement. Commission staff has reviewed the Natural Gas Purchase and Sales Agreement and recommends Commission approval of the Agreement.

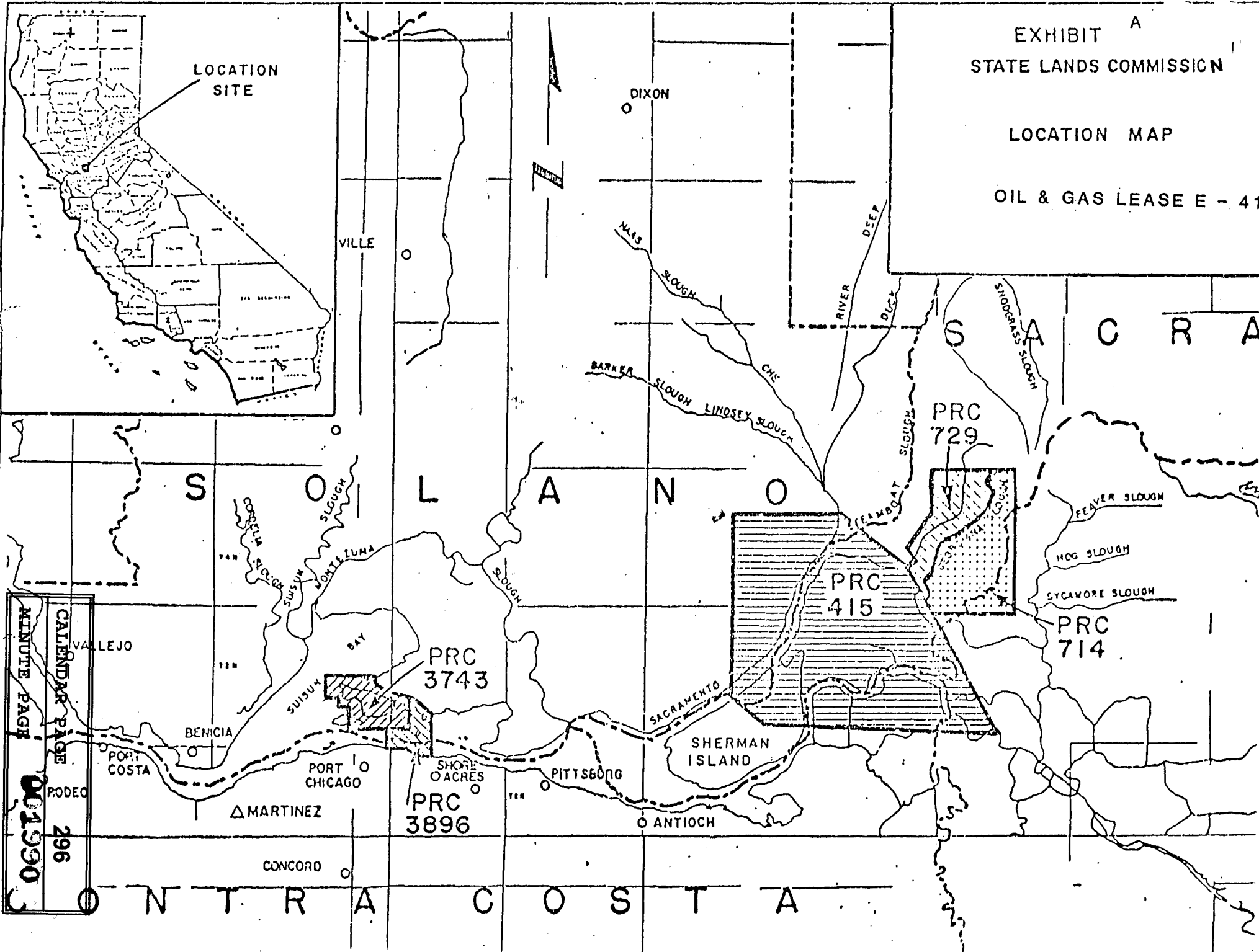
