GENERAL LEASE - RECREATIONAL USE

LESSEE:

James H. Bequette
P.O. Box 373
Isleton, California 95641

AREA, LAND TYPE, AND LOCATION:

0.05 acres, more or less, of tide and submerged lands in the Sacramento River, city of Isleton, Sacramento County.

AUTHORIZED USE:

76 inch x 61 foot floating dock with walkway.

LEASE TERM:

Ten years, beginning August 1, 1997.

CONSIDERATION:

\$271 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

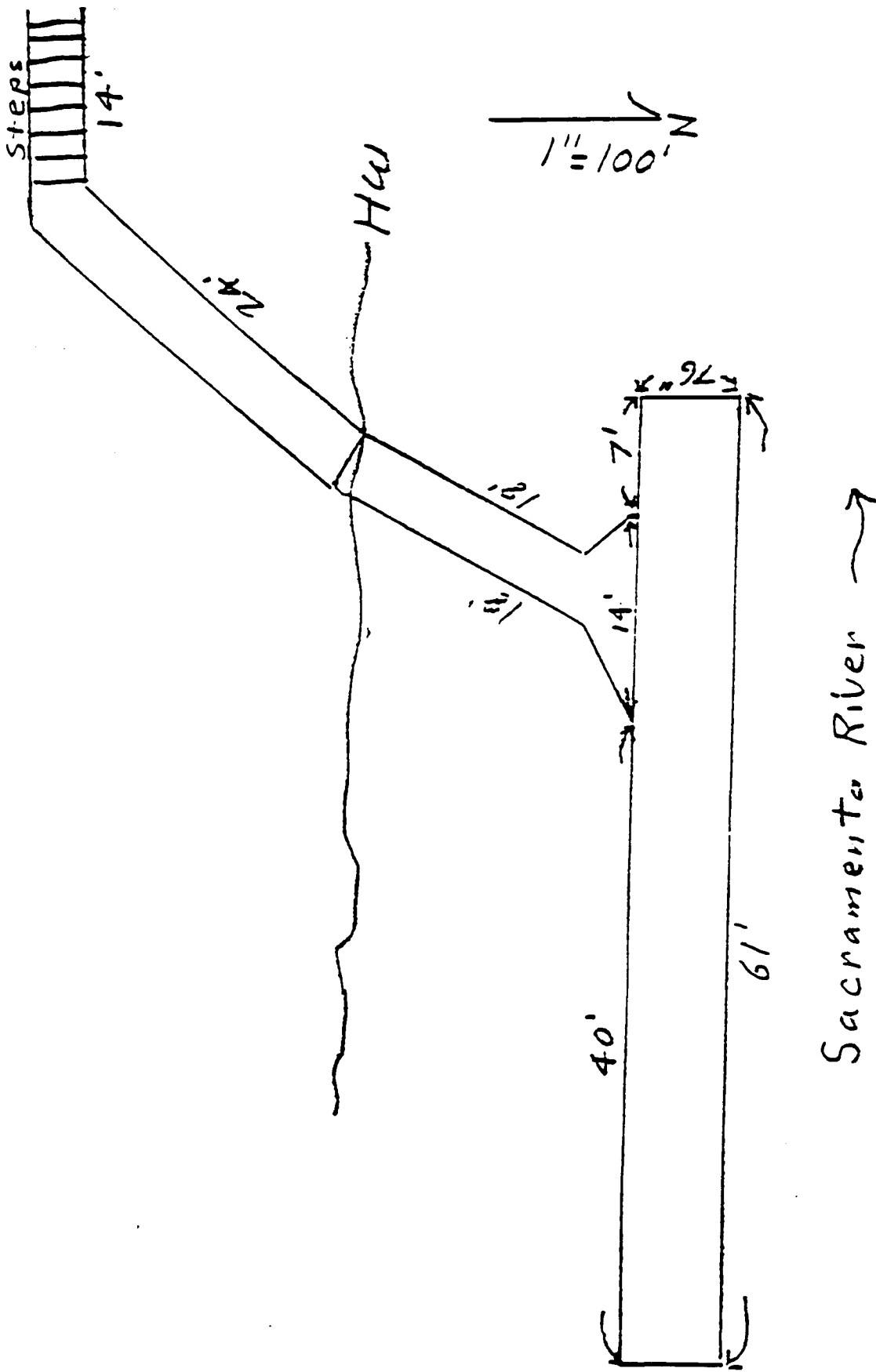

A PART HEREOF; CONSIDERATION TO BE ANNUAL RENT IN THE AMOUNT OF \$271, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF NO LESS THAN \$500,000.

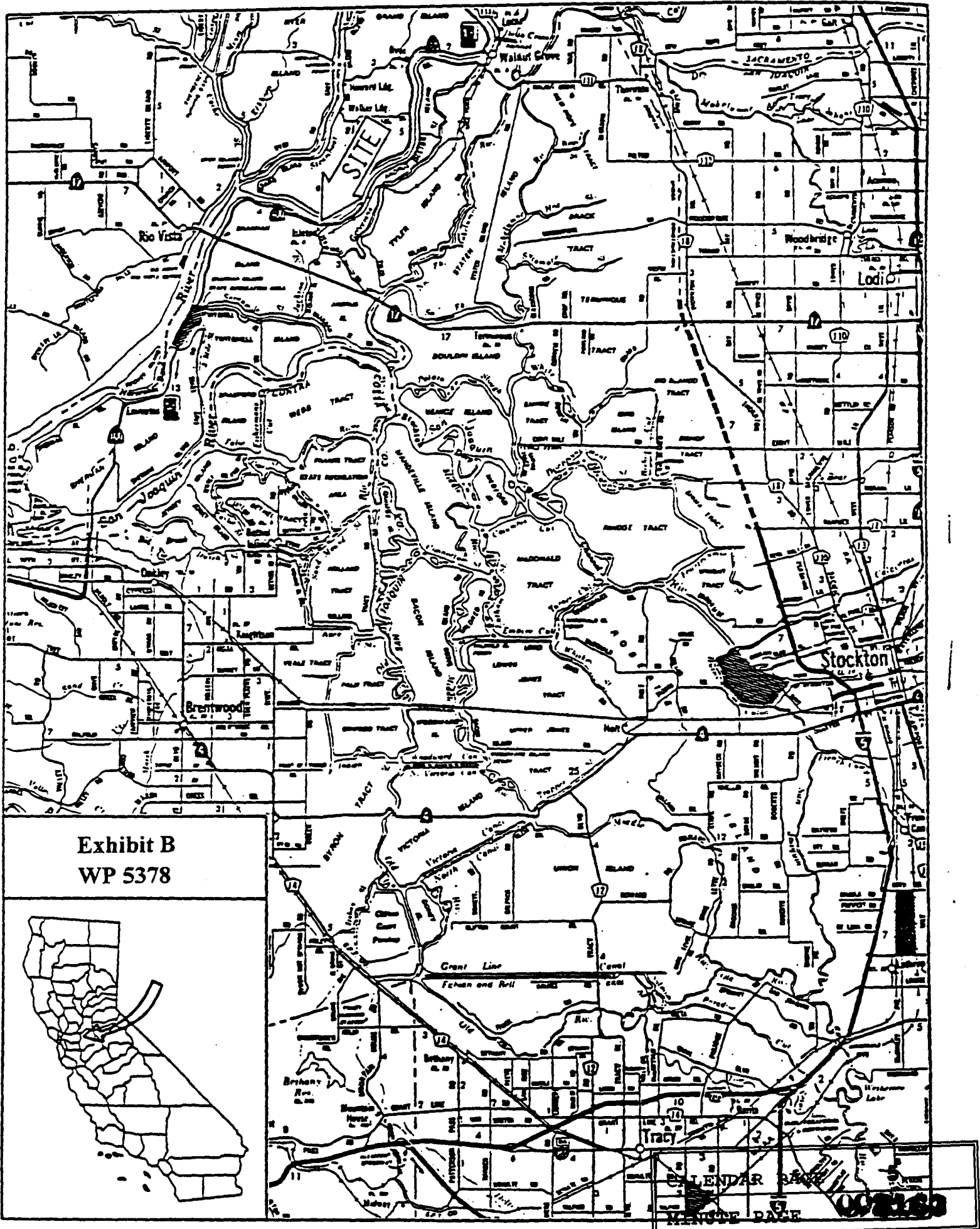
