RECREATIONAL PIER LEASE

APPLICANT:

Ernest Fred Grether, Jr., as Trustee of the Community Property Trust, as described in instrument entitled Amended Declaration of Trust - Ernest Fred Grether, Jr. and Margaret Ruth Read Grether, dated February 12, 1981, executed by Ernest Fred Grether, Jr. and Margaret Ruth Read Grether as Trustors

Huntington Beach, California 92649

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, city of Huntington Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of a boat dock and ramp, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning November 30, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a) (2).

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

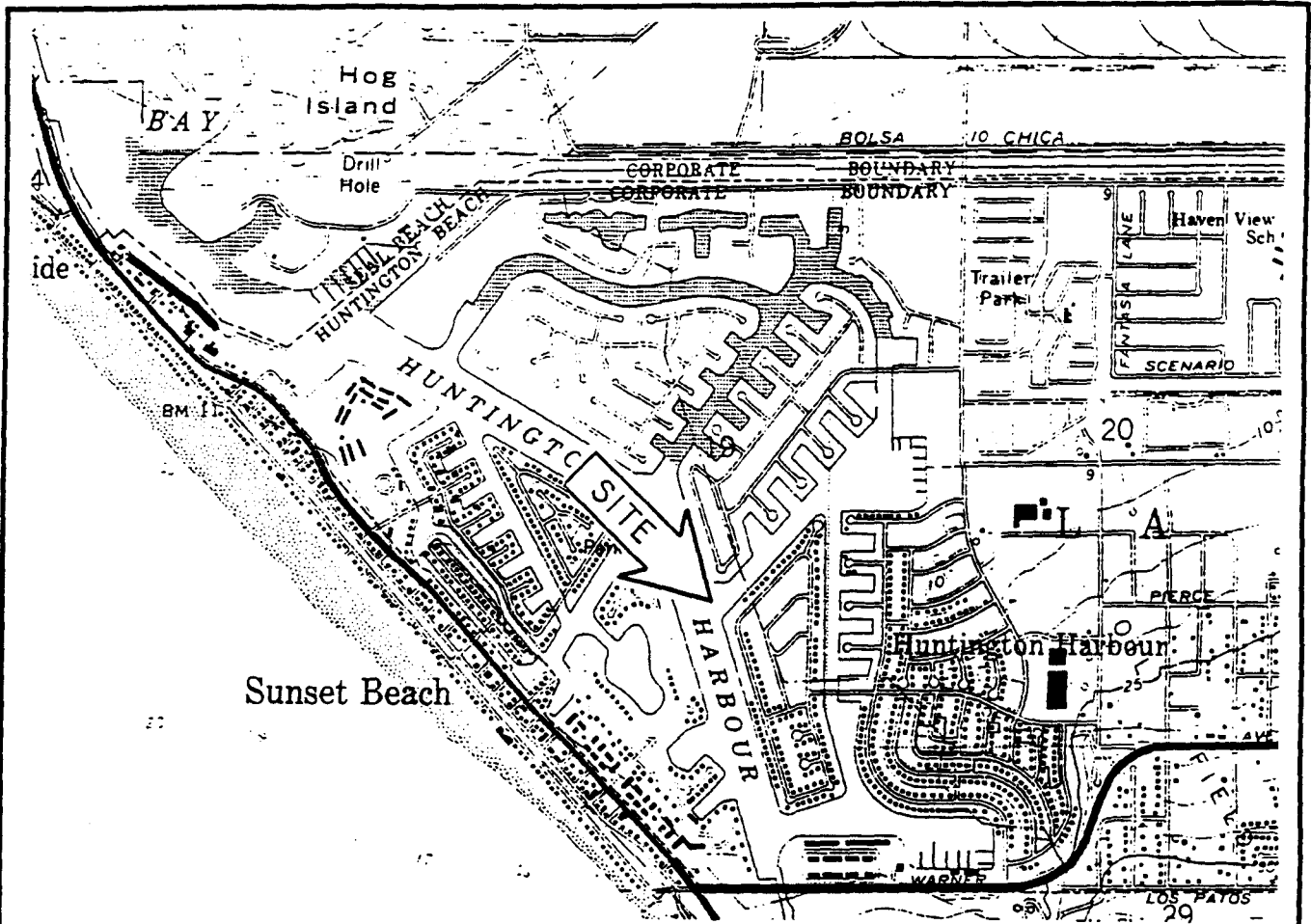

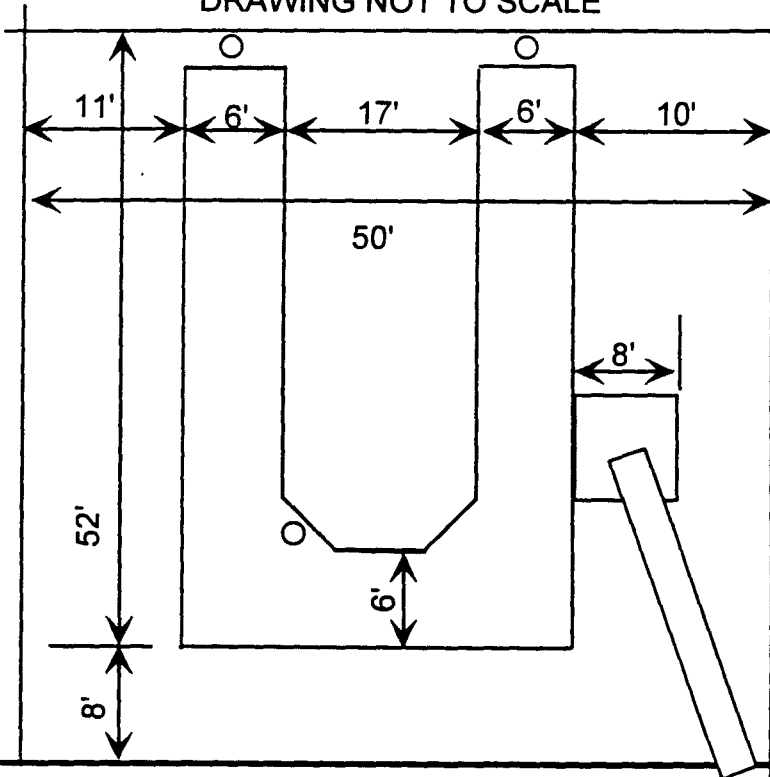
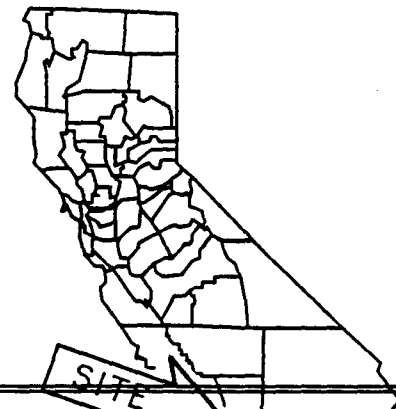


EXHIBIT "A"
