BACKGROUND:

Oil and Gas Lease No. PRC 2793.1 was issued to Richfield Oil Company, Socony Mobil Oil Company and Signal Oil and Gas Company on October 26, 1961. Through a series of corporate mergers and name changes, the present lessees are CH-Twenty, Inc., Mobil Oil Corporation and Phillips Petroleum Company. CH-Twenty, Inc., is the operator for the lease. CH-Twenty, Inc., is now requesting that the State Lands Commission approve assignment of 61 percent interest in this lease to ARCO Environmental Remediation, LLC.

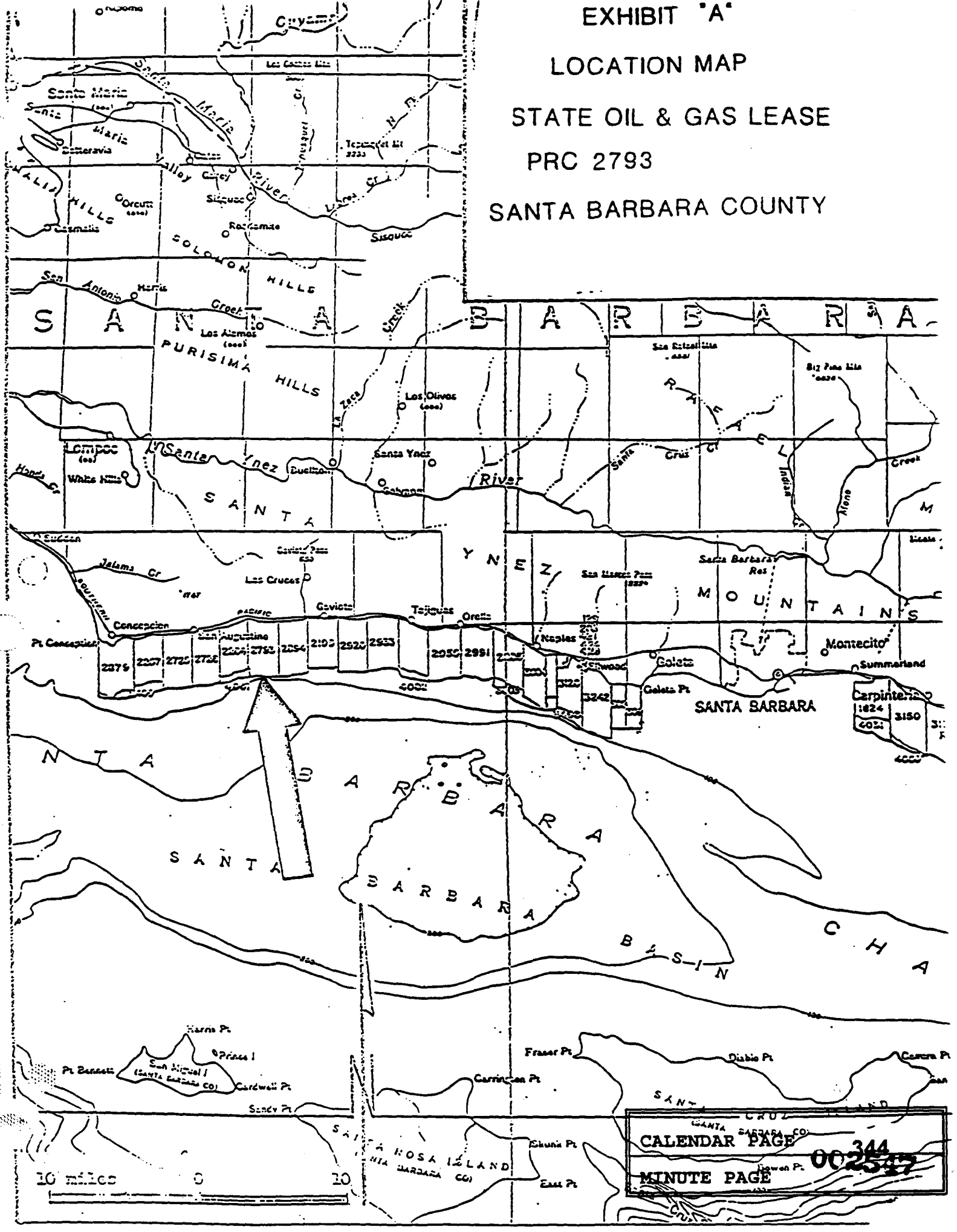
