### DREDGING LEASE

### LESSEE:

Kiewit Pacific Company P. O. Box 71 100 Solano Avenue Vallejo, California 94590

### AREA, LAND TYPE, AND LOCATION:

Granted, minerals reserved, sovereign lands at the Vallejo Waterfront, Mare Island Strait, city of Vallejo, Solano County.

### AUTHORIZED USE:

Maintenance dredge a maximum of 22,000 cubic yards of material to maintain a navigable depth. Dredged materials will be disposed of within settlement ponds located on the upland portion of the project.

### LEASE TERM:

Five years, beginning March 1, 1998.

### **CONSIDERATION:**

No royalty will be charged for disposal of dredged material; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

### **OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304(g).
