AREA, LAND TYPE, AND LOCATION:

Tide and submerged lands in the Calaveras River, near Stockton, San Joaquin County.

AUTHORIZED USE:

Continued use and maintenance of an existing 8 foot x 60 foot floating boat dock, a 6 foot x 34 foot walkway, and an 8 foot x 20 foot platform.

LEASE TERM:

Ten years, beginning March 13, 1998.


