for the operation and maintenance of mooring and anchorage sites and piers at various coves around Santa Catalina Island. These leases contained certain requirements that govern the operation of these sites and the services that were to be provided to the public users of these sites. The current leases, presently in holdover, contain provisions that allow the Lessees, with the permission of the Commission, to contract with an Operator to manage the moorings and piers and to provide other services required by the leases. The Lessees' approved Operator for the past thirty-five plus years has been Doug Bombard Enterprises.

## **CURRENT SITUATION:**

Because Mr. Bombard is retiring, he has advised the Lessees that his company, Doug Bombard Enterprises, no longer wishes to act as Operator under the Commission's leases. The Lessees are requesting approval from the Commission to assign operation responsibilities to a new company. The new company, Two Harbors Enterprises, Inc., is a wholly-owned subsidiary of the Santa Catalina Island Company formed specifically to become the Operator of the leases from the Commission. Approval of this new Operator will assure the continuation of existing operations under the Commission's leases.

#### OTHER PERTINENT INFORMATION:

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.
