LEASE RENEWAL

APPLICANT:

Margaret G. Pelham
Pelham Bay Resort
24620 Tehama Vina Road
Los Molinos, California 96055

AREA, LAND TYPE, AND LOCATION:

0.06 acres, more or less, of submerged lands in the Sacramento River (APN 066-140-07), near the town of Los Molinos, Tehama County.

AUTHORIZED USE:

8 foot x 80 foot floating dock with walkway.

PREVIOUS LEASE TERM(S):

Ten years, beginning June 1, 1988.

PROPOSED LEASE TERM:

Ten years, beginning June 1, 1998.

CONSIDERATION:

\$300 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of no less than \$1,000,000.

Bond: \$1,000

OTHER PERTINENT INFORMATION:

- 1. Applicant owns the uplands adjoining the lease premises.

2. The applicant's dock was destroyed due to high water flows during this year's floods. Applicant proposes to replace the dock in kind.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction; Title 2, California Code of Regulations, section 2905(b).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et. seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.





PELHAM OF A GENERAL LEASE - RECREATIONAL USE, BEGINNING JUNE 1, 1998, FOR A TERM OF TEN YEARS, FOR AN EXISTING FLOATING DOCK AND WALKWAY ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$300, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF NO LESS THAN \$1,000,000; SURETY IN THE AMOUNT OF \$1,000.

TEHAMA COUNTY




