AREA, LAND TYPE, AND LOCATION:

Tract No. 1, Long Beach Unit, Wilmington Oil Field, Los Angeles County

BACKGROUND:

The Crude Oil Sales Contract for Tract No. 1 (7% Segment), Long Beach Unit was issued to EOTT Energy Corporation (EOTT) on January 7, 1998. EOTT is the purchaser for the Crude Oil Sales Contract. EOTT is now requesting that the California State Lands Commission (Commission) approve assignment of 100 percent interest in this contract to Paramount Petroleum Corporation (Paramount). This is a 18-month contract that will begin on September 1, 1998. The Commission must approve assignments of a crude oil sales contract involving tidelands' crude oil for it to become effective.

As required by provisions of the Crude Oil Sales Contract, Paramount will be required to submit to the City a Two Million Dollar (\$2,000,000) Letter of Credit and Certificate of Liability Insurance for Four Million Dollars (\$4,000,000). This

will insure Paramount's performance under the Crude Oil Sales contract. In addition, it should be noted that Paramount holds two Royalty Oil Sales Contracts issued by the Commission which will commence in June and July, 1998.
