**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands located in the Pacific Ocean, adjacent to the Samoa Peninsula  
near Eureka, Humboldt County.

**AUTHORIZED USE:**

Operation and maintenance of an existing 36-inch inside diameter wastewater  
discharge outfall pipeline utilized in the processing of woodchips into bleached  
pulp for commercial purposes, as shown on the attached Exhibit A.

**LEASE TERM:**

30 years, beginning July 22, 1993.

**CONSIDERATION:**

\$6,314.40 per year; with the State reserving the right to fix a different rent  
periodically during the lease term, as provided in the lease.

1. Applicant owns the uplands adjoining the lease premises.


