### DREDGING LEASE

### LESSEE:

San Francisco Drydock Inc. P. O. Box 7644 San Francisco, California 94120

### AREA, LAND TYPE, AND LOCATION:

Granted sovereign lands with minerals reserved, at San Francisco Drydock Piers 1 and 2, Port of San Francisco, City and County of San Francisco.

### **AUTHORIZED USE:**

Maintenance dredge a maximum of 266,000 cubic yards of material to maintain a navigable depth. Dredged materials will be disposed of at the United States Army Corps of Engineers approved Alcatraz Disposal Site (SF-11).

### **LEASE TERM:**

Five years, beginning July 1, 1998.

### CONSIDERATION:

No royalty will be charged for disposal of dredged material; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

### OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304(g).


