RECREATIONAL PIER LEASE

APPLICANTS:

Sea Harbour State Channel Slip Owners Association, Inc.
16991 Bluewater Lane
Huntington Beach, California 92649

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, in the city of Huntington Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of 35 existing boat docks, as shown on Exhibit A attached.

LEASE TERM:

Ten years, beginning October 1, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.



AUTHORIZE ISSUANCE, TO SEA HARBOUR STATE CHANNEL SLIP OWNERS ASSOCIATION, INC., OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING OCTOBER 1, 1998, FOR CONTINUED USE AND MAINTENANCE OF THIRTY FIVE EXISTING BOAT DOCKS ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$300,000.




EXHIBIT "A"
