**AREA, LAND TYPE, AND LOCATION:**

Oil and Gas Lease No. PRC 5995 (Parcel 1) consists of 86 acres of tide and submerged lands lying in the bed of Lindsey Slough in Solano County.

**BACKGROUND:**

Oil and Gas Lease No. PRC 5995.1 was issued to Casex-Seahawk on April 29, 1981. Through a series of corporate mergers and name changes, the present lessee is Casex-Pittencrieff. Casex Company is the operator for the lease. Oil and Gas Lease No. PRC 5995.1 currently has two producing wells, the Sea Hawk 1-1, producing 5,504 mcf/day, and the Sea Hawk 1-2, producing 3,432 mcf/day. In August 1998, State royalty for these two wells was \$3,638.54. Pittencrieff America, Inc., (Pittencrieff) is now requesting that the California State Lands Commission approve assignment of all of Pittencrieff's right, title and interest in the lease to Casex Company.

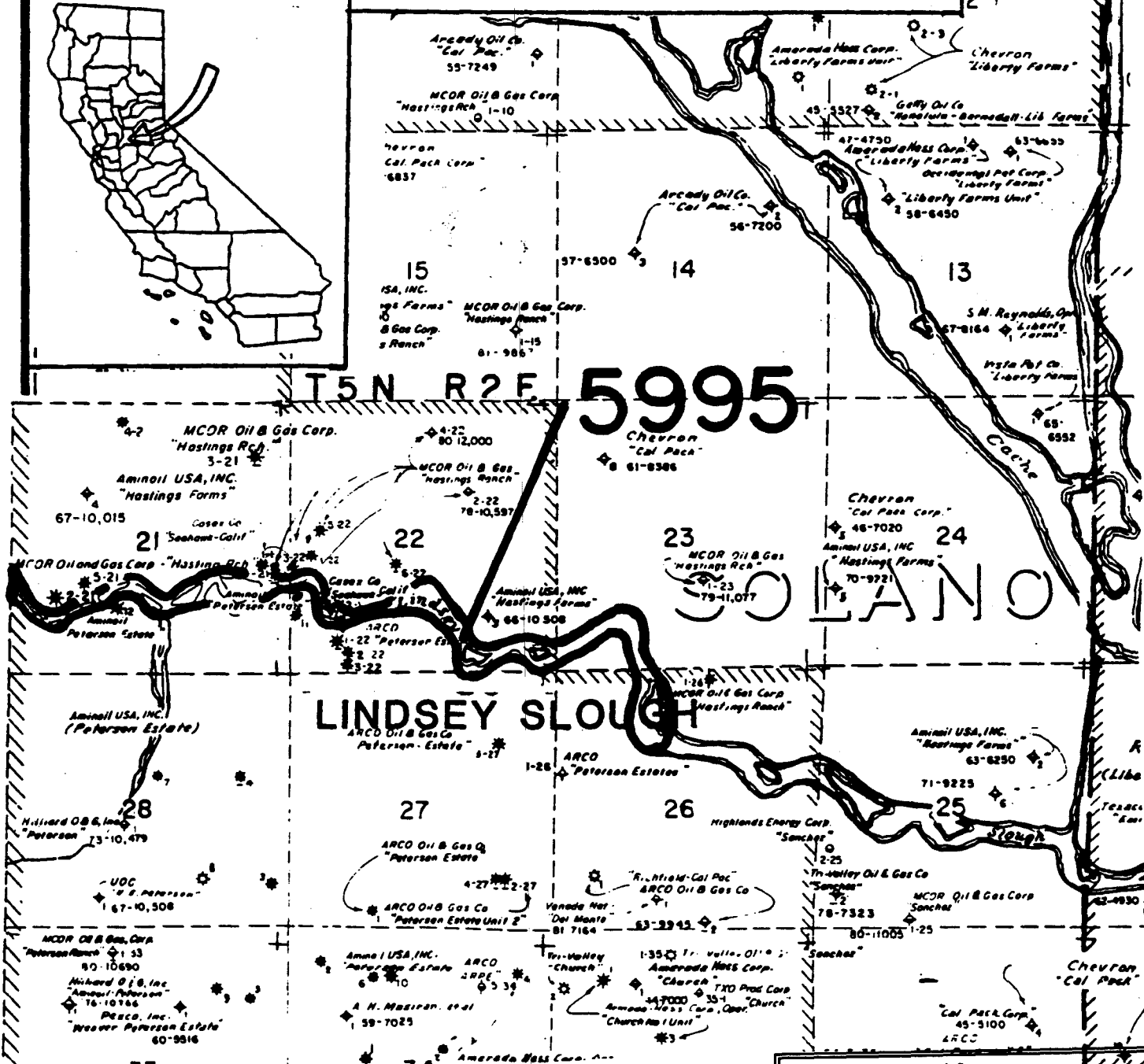

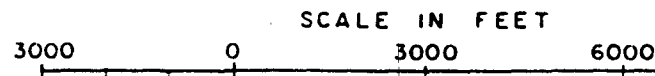
