Station that will be sold to Ormond Beach Power Generation, L. L. C. (OBGS). Operation of the Ormond Beach Generating Station is subject to a number of existing regulatory permits and licenses, including State Lease No. PRC 4196.1. Lease No. PRC 4196.1 was issued by the California State Lands Commission (CSLC) to SCE for the installation and maintenance of cooling water conduits.

- 3. As part of the sale of the Ormond Beach Generating Station, SCE has requested the CSLC to consider assigning all of its right, title and interest in Lease No. PRC 4196.1 to OBGS.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.
