**AMENDMENT OF DREDGING LEASE TO EXTEND TERM  
AND MODIFY DISPOSAL AREA**

**LESSEE:**

Crescent City Harbor District  
101 Citizens Dock Road  
Crescent City, California 95531

**AREA, LAND TYPE, AND LOCATION:**

Granted sovereign lands with minerals reserved to the State in the Crescent City Harbor, Crescent City, Del Norte County.

**AUTHORIZED USE:**

Maintenance dredging of 75,000 cubic yards annually from the Crescent City Harbor.

**LEASE TERM:**

Ten years, beginning August 11, 1988.

**CONSIDERATION:**

No royalty will be charged as the project will result in a public benefit. A royalty of a minimum of \$0.25 per cubic yard shall be paid for any material sold or used for any private benefit or commercial sale purposes.

**PROPOSED AMENDMENT:**

1. The expiration date of this lease shall be extended from August 10, 1998 to March 19, 1999.
2. Dredge Area No. 5 shall be eliminated from the lease area, and no further dredging shall occur within Area No. 5 without written consent from Lessor throughout the term of the lease.
3. All other terms and conditions of the lease shall remain in full force and effect.

**OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land; Title 14, California Code of Regulations, section 15304 (g).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

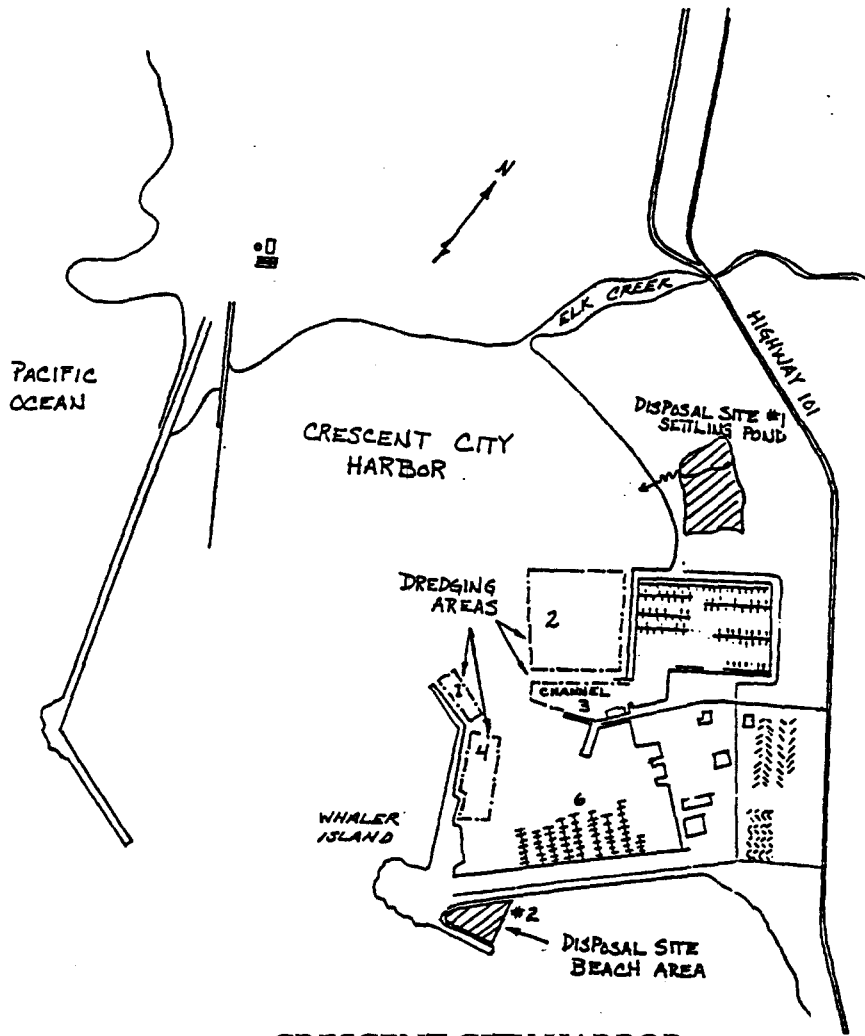

# LOCATION MAP

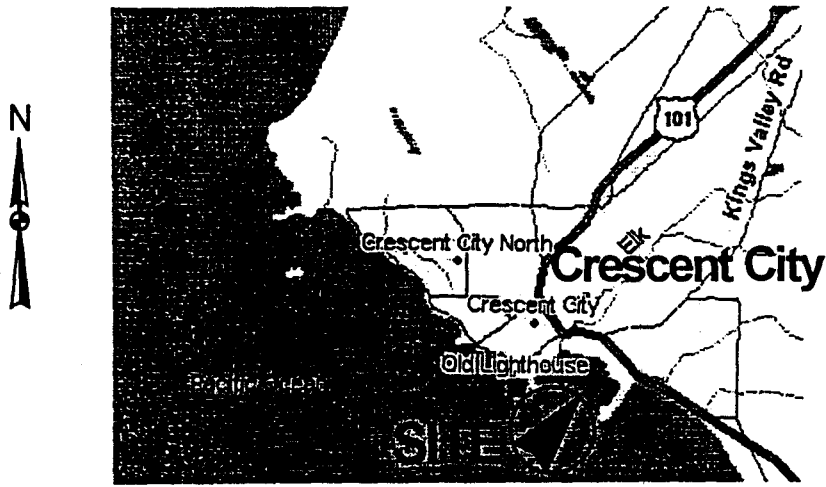
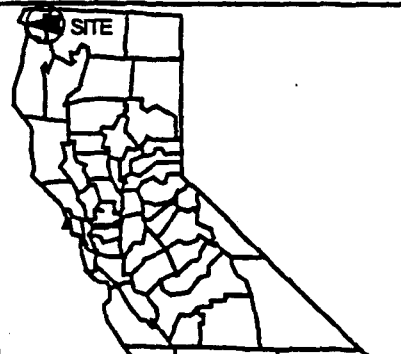


Exhibit A
