RECREATIONAL PIER LEASE

APPLICANT:

The Mencarini Family Trust Dated July 29, 1998
3563 Garden Highway
Sacramento, California 95834

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, near the city of Sacramento,
Sacramento County.

AUTHORIZED USE:

The continued use and maintenance of an existing 6 foot by 40 foot floating boat dock and 4 foot by 40 foot gangway.

LEASE TERM:

Ten years, beginning January 15, 1999.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

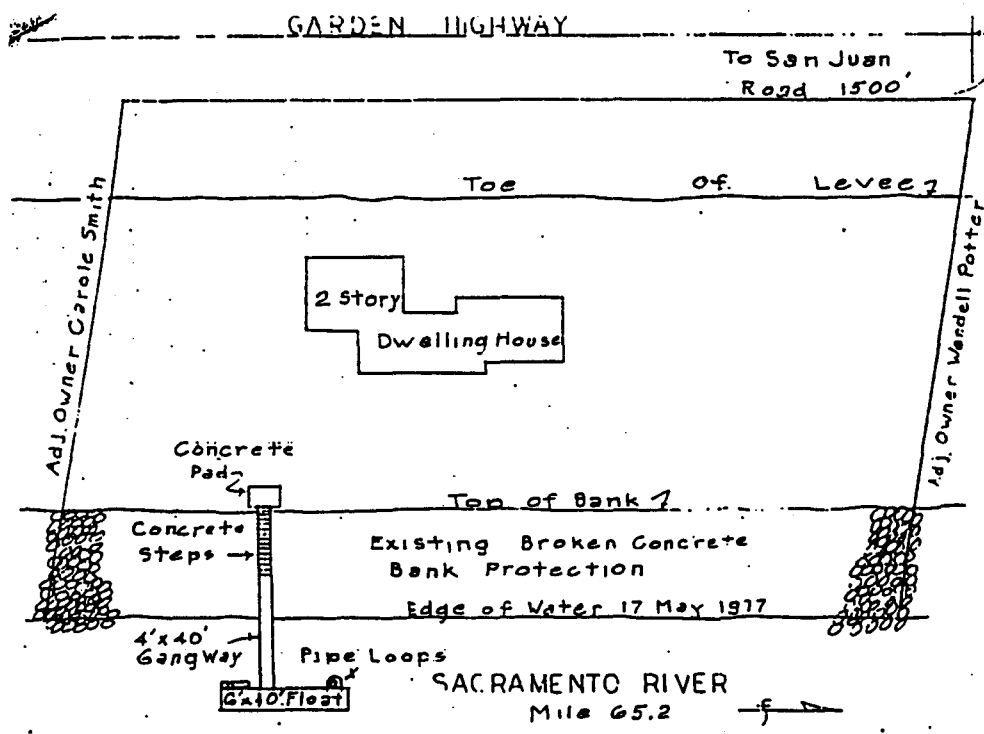

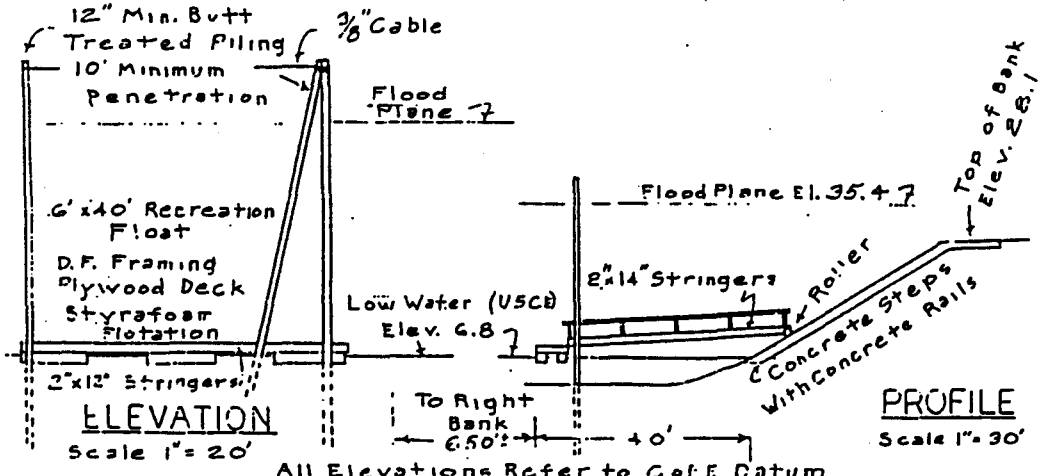
AUTHORIZATION:

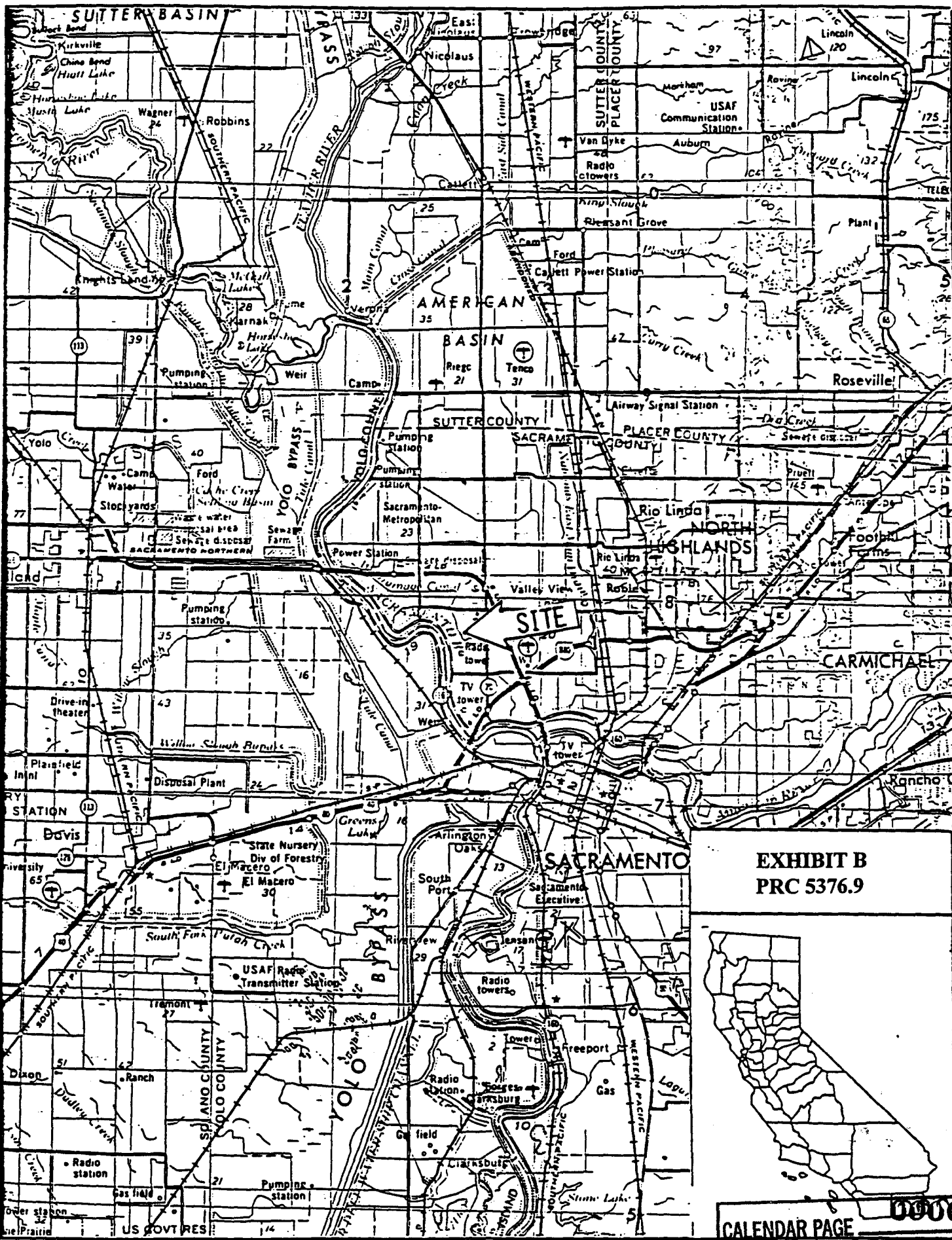
