**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Corte Madera Creek, Greenbrae, Marin County.

**AUTHORIZED USE:**

Use and maintenance of an existing gangway and floating dock as shown on attached Exhibit A.

**LEASE TERM:**

Ten years, beginning March 1, 1999.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

**Insurance:**

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**






