**CONTINUATION OF RENT
GENERAL LEASE - RIGHT-OF-WAY USE**

LESSEE:

Pacific Lumber Company
General Delivery
Scotia, California 95565

AREA, LAND TYPE, AND LOCATION:

0.26 acres, more or less, of sovereign lands in the Eel River, near Dyerville,
Humboldt County.

AUTHORIZED USE:

Continued use and maintenance of railroad flat car, seasonal bridge crossing in
the Eel River, as described in the attached Exhibit A.

LEASE TERM:

30 years, beginning July 28, 1981.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff has conducted a review of the rent under
this lease, and recommends that the rent be continued at \$100 per year,
effective July 28, 1998.

LAND DESCRIPTION

A strip of submerged land 50 feet wide in the bed of the Eel River, situated within the N-1/2 of the SE-1/4 of Section 26, T1S, R2E, HM in Humboldt County, California, said strip lying 25 feet on each side of the following described line:

COMMENCING at the east quarter corner of said Section 26, thence the following two courses:

1. West 1195 feet;
2. South 202 feet to a point on the low water mark on the east bank of the Eel River and the TRUE POINT OF BEGINNING of this line; thence
3. N 75° W 225 feet to a point on the low water mark on the west bank of the Eel River and the end of this line.

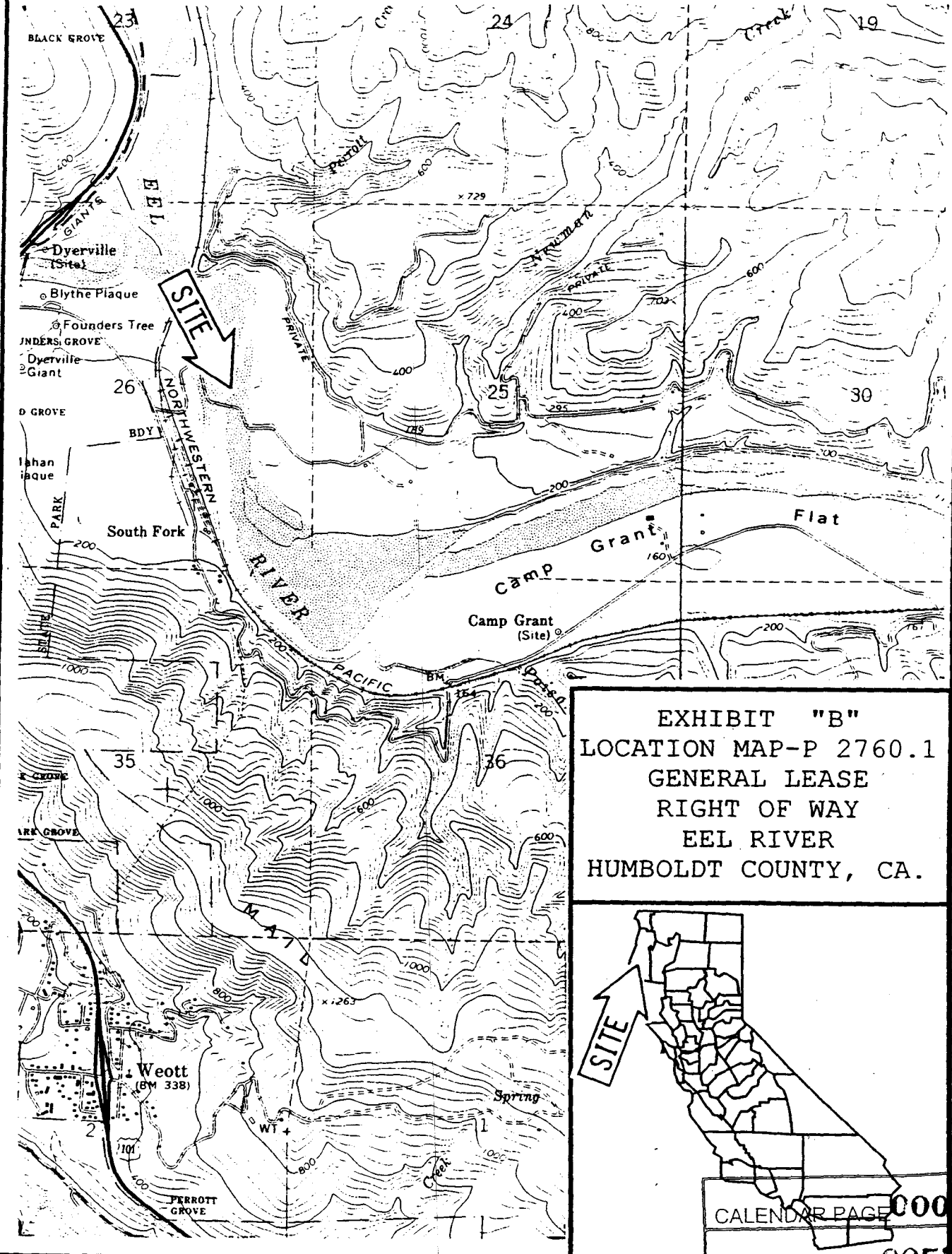
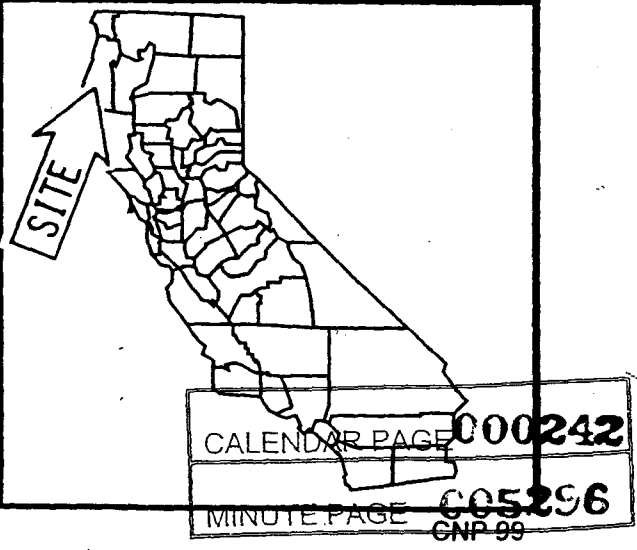


EXHIBIT "B"
