GENERAL LEASE - RECREATIONAL USE

APPLICANT:

The Gar Wood Building, A California Limited Partnership
Attention: Tom Turner

Carnelian Bay, California 96140-1133

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a restaurant accommodation pier, fourteen mooring buoys and three U.S. Coast Guard marker buoys, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning June 1, 1999.

CONSIDERATION:

\$2,403 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Liability insurance: Combined single limit coverage of \$1,000,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

AUTHORIZE ISSUANCE TO THE GAR WOOD BUILDING, A CALIFORNIA LIMITED PARTNERSHIP, OF A GENERAL LEASE - RECREATIONAL USE, FOR A TERM OF TEN YEARS BEGINNING JUNE 1, 1999, FOR CONTINUED USE AND MAINTENANCE OF A RESTAURANT ACCOMMODATION PIER, FOURTEEN MOORING BUOYS AND THREE U.S. COAST GUARD MARKER BUOYS ON THE LAND SHOWN ON EXHIBIT A, ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$2,403; WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$1,000,000.
