**CONSIDER ACCEPTANCE OF QUITCLAIM DEED AND  
TERMINATION OF GENERAL PERMIT – RECREATIONAL USE**

**LESSEE:**

Fay Ranch, Inc.  
412 Coloma Street  
Sausalito, California 94965

**AREA, LAND TYPE, AND LOCATION:**

0.07 acres, more or less, of tide and submerged lands in Steamboat Slough, adjacent to Grand Island, near the city of Rio Vista, Sacramento County.

**AUTHORIZED USE:**

An existing 7 foot by 30 foot floating wharf, ramp, dock and two pilings.

**LEASE TERM:**

15 years, beginning February 26, 1987.

**CONSIDERATION:**

\$375 per year; with the State reserving the right to fix a different rent periodically during the lease term as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance: Combined single limited coverage of \$500,000.

Bond:

\$1,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the uplands adjoining the lease premises.
2. On January 5, 2000, Lessee removed all authorized improvements, including the floating wharf, dock, ramp and two pilings from the lease area.

## LAND DESCRIPTION

PRC 4753.1

A parcel of tide and submerged land lying in the bed of Steamboat Slough, Sacramento County, State of California, being adjacent to Grand Island and described as follows:

BEGINNING at a point on the easterly bank of Steamboat Slough which bears S 8°00' W 140.00 feet from the northwest corner of the parcel of land described in the Grant Deed recorded in Book 452 Official Records page 216 Sacramento County Records, running thence from said point of beginning into Steamboat Slough and at right angles to said easterly bank of Steamboat Slough 60 feet; thence 50 feet northerly, parallel with, and distance 60 feet from said easterly bank of Steamboat Slough; thence 60 feet easterly at right angles to said easterly bank of Steamboat Slough; thence southerly along said easterly bank 50 feet to the point of beginning.

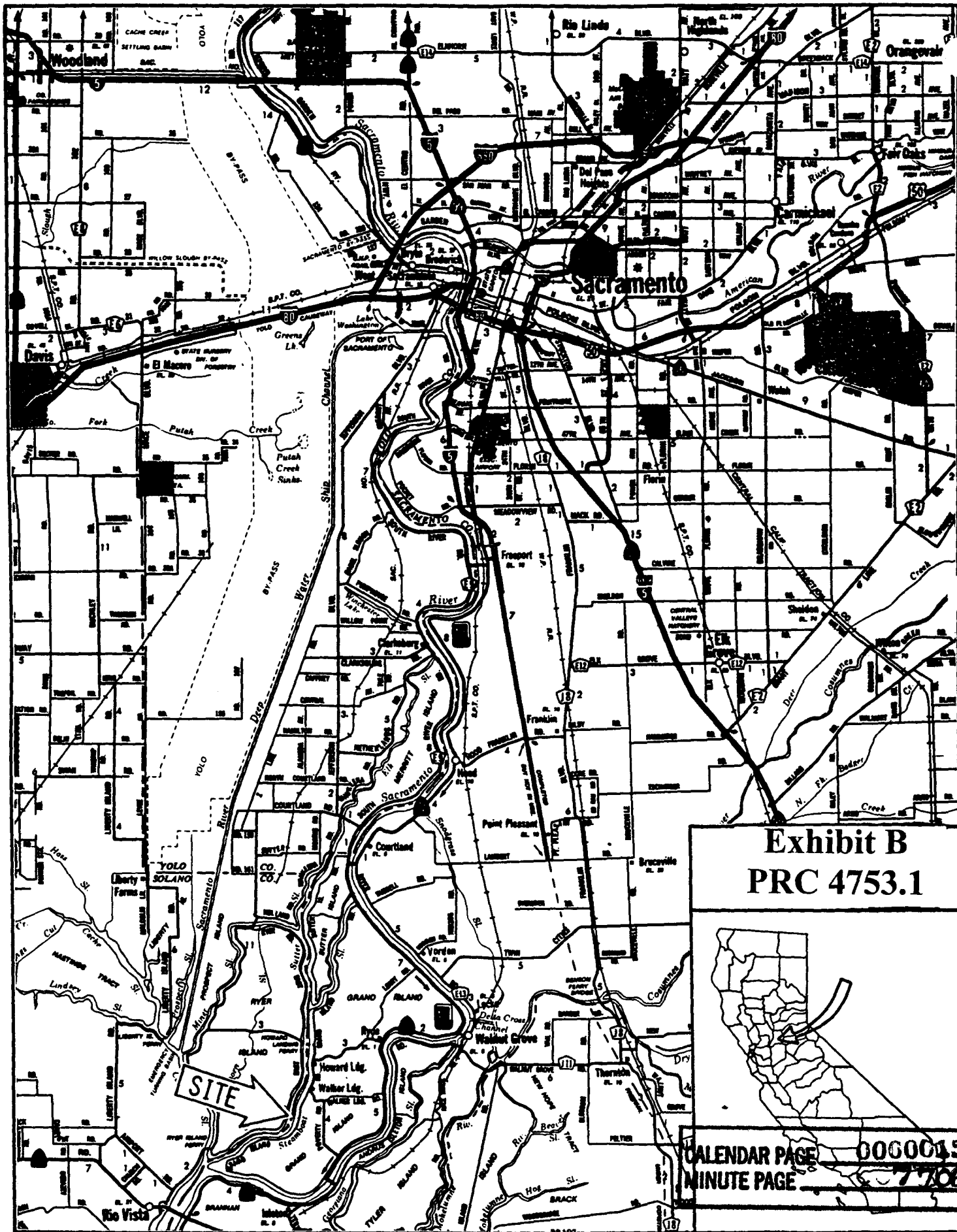
EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark.

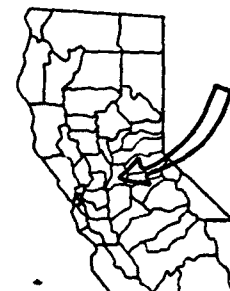
