RECREATIONAL PIER LEASE

APPLICANT:

Stanford G. Goulding Surviving Trustee of the Goulding Family Trust dated 1988
P.O. Box 240
Sunset Beach, CA 90742

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, near Huntington Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of existing boat dock as shown on Exhibit A
attached.

LEASE TERM:

Ten years, beginning November 20, 1999.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. LOCATION MAP *Huntington Harbour*

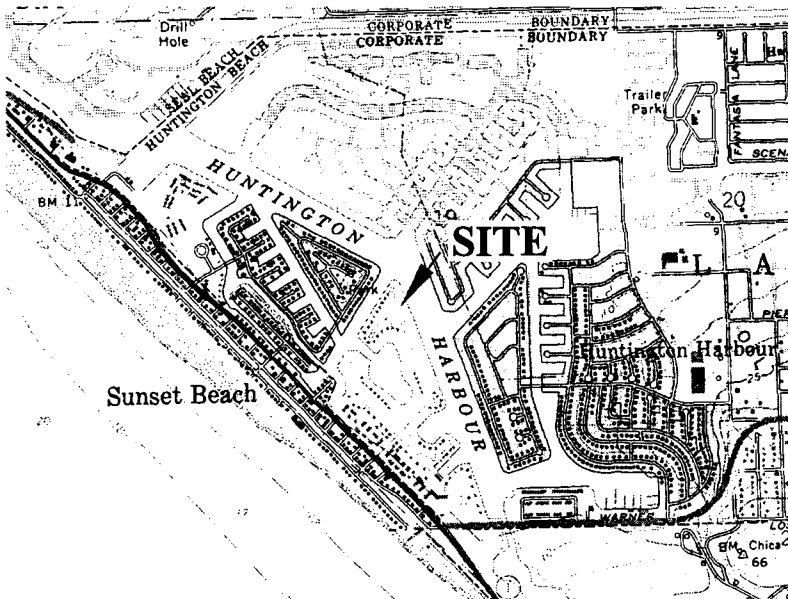
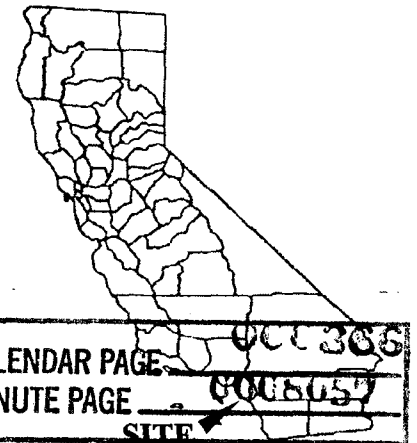
