RECREATIONAL PIER LEASE

APPLICANT:

George Carl Frederic, as Trustee under a revocable
Declaration of Trust dated October 17, 1985
P. O. Box 6152
Incline Village, Nevada 89450

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to the Garden Highway, near
the city of Sacramento, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing six foot by 60 foot floating dock
with metal ramp.

LEASE TERM:

Ten years, beginning July 24, 2000.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA
Guidelines (Title 14, California Code of Regulations, section 15061), the
staff has determined that this activity is exempt from the requirements of
the CEQA as a categorically exempt project. The project is exempt under
Class 1, Existing Facilities; Title 2, California Code of Regulations,
section 2905 (a)(2).





