**AMENDMENT OF LEASE**

**LESSEE:**

Windland, Inc.  
10448 Garverdale Court, Suite 606  
Boise, Idaho 83704

**AREA, LAND TYPE, AND LOCATION:**

0.91 acres, more or less, of school lands in the Northeast 1/4 of the Northeast 1/4, Section 18, Township 11N, Range 13W, SBM, near Mojave, Kern County.

**AUTHORIZED USE:**

Graded dirt access road and drainage culvert to facilitate access to a wind farm located on private property.

**LEASE TERM:**

Twenty years, beginning September 1, 1999.

**CONSIDERATION:**

\$100 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**PROPOSED AMENDMENT:**

Extend the lease term an additional ten years, to expire August 31, 2029. All other terms and conditions of the lease shall remain in effect without amendment.

**OTHER PERTINENT INFORMATION:**

1. Lessee owns the lands adjoining the lease premises.
2. Lessee is requesting that the lease term be extended to be consistent with their long-term lease for the wind energy plant to be constructed on the Lessee's property.

3. A Mitigated Negative Declaration was prepared and adopted for this project by Kern County. The Commission reviewed the Mitigated Negative Declaration document and adopted the Mitigation Monitoring Program at its meeting on September 3, 1999, pursuant to Minute Item 44.
4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



