RECREATIONAL PIER LEASE

APPLICANT:

James M. Cameron
2385 Garden Highway
Sacramento, California 95833

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to the Garden Highway, near the city of Sacramento, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing 5 foot by 23 foot floating dock and ramp.

LEASE TERM:

Ten years, beginning October 26, 1999.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On October 26, 1989, the Commission authorized a Recreational Pier Permit with James M. Cameron. That lease expired October 25, 1999. This item qualifies as a rent-free Recreational Pier lease because the Applicant is a natural person who has improved the littoral land with, and only uses the upland for, a single family dwelling. James M. Cameron is now applying for a new Recreational Pier Lease.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the

staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

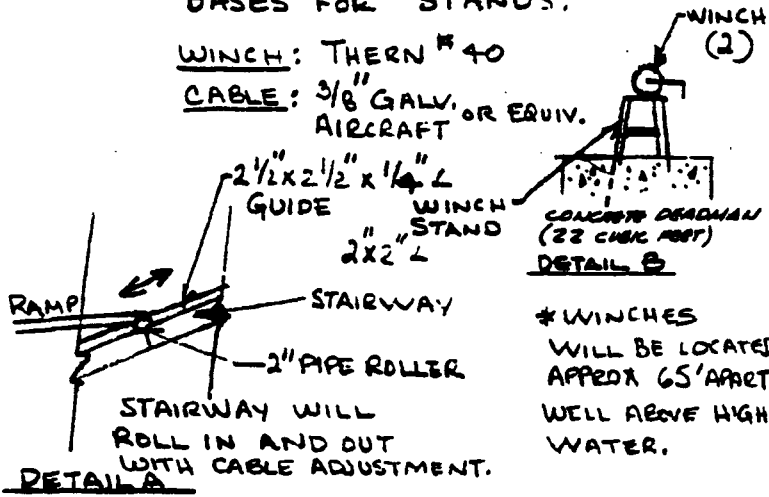
AUTHORIZATION:
